- Proof of eligibility to reside in Canada.
- Criminal record check including vulnerable sector check obtained in the past 90 days. (Obtain from RCMP or local police and attach with your application package.)
- Set of processed fingerprint results from the RCMP.
- Verification of employment for business professions form.
- 2 passport sized photographs.
- Current Authorization to Carry (ATC) permit. (Required if you provide armored car security.)
- Payment information form.
