



BABY BASKET PROJECT RELEASE (THE "RELEASE")

IN CONSIDERATION for receiving a Baby Basket (the "Basket") from the Government of Yukon as represented by the Minister of Health and Social Services ("YG"), I, warrant, ACKNOWLEDGE, AND AGREE irrevocably on behalf of myself, my heirs, executors, administrators, personal representatives, next of kin and assigns to the following terms and conditions:

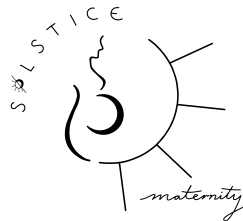
1. I understand and agree that all products and goods that are in the Basket are not produced by YG. If I have any concerns about any products and goods in the Basket, have an expired or defective product or good in the Basket, or have questions about the Basket I need to contact HSS.
2. I assume and accept, freely and voluntarily, without qualification or limitation, ALL RISKS and dangers related to or arising from the Basket.
3. I, RELEASE, WAIVE AND FULLY AND FOREVER DISCHARGE YG, and its officers, directors, elected officials, employees, contractors, agents, successors, and assigns from any and all: claims, liabilities, actions, proceedings, damages (including: direct, indirect, consequential, incidental, general, special or exemplary damages, any economic losses, lost profits, lost opportunities, and all other costs, expenses and losses of any type for any reason), or any other legal remedy in any way or for any reason (collectively, the "Claims"), directly or indirectly, related to or arising from the Basket.
4. I, shall HOLD HARMLESS and FULLY INDEMNIFY YG, and its officers, directors, elected officials, employees, contractors, agents, successors, and assigns from and against any and all claims, liabilities, actions, proceedings, demands, damages, losses, costs or expenses (including legal costs), directly or indirectly, related to or arising from the Basket.
5. This Agreement will be deemed to have been made in and will be governed, interpreted, and enforced by the laws of the Yukon without regard to conflict of law principles that would impose a law of another jurisdiction, and both Parties irrevocably submit to the exclusive jurisdiction of the courts in Yukon.
6. I HAVE READ THIS AGREEMENT THOROUGHLY and UNDERSTAND THAT GY IS RELYING ON MY FULL RELEASE OF ALL CLAIMS AND INDEMNITY IN EXCHANGE FOR THE BASKET.
7. I, acknowledge and agree that all the terms and conditions of this Agreement are set out herein in their entirety and that the execution of this Agreement has not been induced by, nor have I, relied upon, any representation, warranty, condition, or agreement, whether written or oral, other than as expressly set out or referred to herein.
