FINANCIAL REPORTING - CHECKLIST

Use this checklist to ensure you meet all of your licence's reporting requirements.

Profess	e <mark>rly reporting</mark> sional Licensing and Regulatory Affairs (PLRA) requires you to submit the following every three months after your e starts.
	☐ A completed financial report form, signed and accompanied by a notarized affidavit. A notary at PLRA can sign the form.
	☐ A completed tracking sheet.
	☐ A completed ticket inventory control sheet.
You mu	ust also send copies of the following for the three-month reporting period. Keep the originals for your records.
	☐ Copies of winning tickets.
	☐ Copies of paid invoices, cancelled cheques, and receipts verifying all your expenses.
	☐ Copies of paid invoices, cancelled cheques, and receipts verifying how you spent your proceeds.
	☐ Copy of a bank statement showing your account balance is at least equal to your unspent proceeds.

Final reporting

Your last financial report is due within 30 days of when your licence ends. It must include the items in the checklist above and the second portion of your licence fee (1% of your gross ticket sales).

Note: You can have a Chartered Professional Accountant prepare your financial reporting, using an audit letter to identify all revenue and all approved uses of proceeds and expenditures for the time period. If you choose this option, you do not need to provide copies of invoices, cheques, receipts and bank statements. However, you are still required to submit all the other checklist items, including the financial report form.

You can submit your completed reporting (forms, copies of supporting documents and any fee) to PLRA in-person, by courier or by mail. We do not accept submissions by email.

If you are also paying your final licence fee, provide a cheque made out to PLRA or complete a credit card information form and include it with your reporting.
