Filing rules

- The registered office delivery and mailing addresses must be in Yukon.
- The registered office delivery address cannot be a post office box.
- A member-funded society must have at least one director. (The director is NOT required to be resident in Yukon)
- A class A or B society must have at least three (3) directors. At least one director must be ordinarily resident in Yukon.
- You must attach an authorization for the continuation from the official in the extra-territorial society's home jurisdiction whose role in that jurisdiction is similar to the role of the registrar in Yukon.
- You must attach a certificate of incorporation, amalgamation or continuance that is issued by a comparable official in the extra-territorial society's home jurisdiction whose role in that jurisdiction is similar to the role of the registrar in Yukon.
- You must attach a certificate that is issued by a comparable official in the extra-territorial society's home jurisdiction whose role in that jurisdiction is similar to the role of the registrar in Yukon.
- The bylaws **must be approved by special resolution** before submitting this application.
