Where we ended up: Amendments to the Designated Materials Regulation

On October 1, 2018, new surcharges for tires, electronic and electrical products sold in Yukon will apply. These changes are based on information from established systems in other Canadian jurisdictions and engagement with Yukoners.

This engagement process shows the real impact feedback from Yukoners has on decisionmaking.

- 1. Timing: It was important to provide 90 days to retailers to update systems and familiarize themselves with their <u>new responsibilities</u>. We also heard that retailers did not want to make this change during the winter/holiday season.
- 2. Product categories: We heard mixed support for proposed categories and for those of other jurisdictions. The result was to consider all this information and have categories that align with BC for electronics/electrical products and with Alberta for tires.
- 3. Surcharges: We heard support for surcharges equal to those in other jurisdictions. However, we recognized that in Yukon there is additional cost required to establish systems, collect, transport and process these items. We also recognized the surcharge amounts originally proposed required some amendments.

In the charts below you can see how engagement with Yukoners between 2016 and 2018 resulted in changes for these surcharges and categories.
