In the first part of the application process, you will submit ONLY the application form. If your application is successful, it will be placed in a pool from which we will select applications to proceed to the next part of the process. If you are selected, you will be invited to submit the supporting documentation and, finally, to an in-person interview.

Your initial application must meet a minimum score of 65 in order to be assessed. Provide only truthful information, as the supporting documentation you will supply in the next phase MUST match the information you self-declared in the application. If your information changes, please contact us to verify whether a new application would be required.

Only original applications with original signatures that are filled out correctly, completely and legibly will be assessed. Ultimate approval for work permits and permanent residence is the responsibility of the IRCC. The Yukon government does not intervene in or appeal IRCC decisions.
