



## **Planning Committee for the Beaver River Land Use Plan:**

**Mayo Community Meeting** 

**Date: January 21, 2019** 

**Location: Village of Mayo Community Hall** 

Time: 5:00pm. – 8:00p.m.

## In attendance 62 people

Steve B. and Lesley C. introduced the purpose of the evening and provided an introduction to the planning process. The following are comments provided by the meeting attendees;

- There needs to be clarification on who can use the road users need NND permission because road is on settlement land.
- Concern about poaching and cutting wood on traplines. Need to protect water.
- SMA's are possible to protect high value areas
- Information should be gathered one on one as well as community meetings
- The Committee members should go on the land with the elders to better engage
- Planning should be for the entire Steward River Watershed
- FNNND planning committee representatives need to be stronger with YG
- Staking has occurred all around my grandfather's cabin
- Site specific parcels are too small to teach traditional ways
- Impacts of hunting, there are fewer moose, there will be places to go if moose disappears
- Important to have food security for the family
- What happens when moose are depleted it is the bread and butter of the people
- What happens after the mine shuts down could it be like what happened in Faro
- Need to have hunting regulations
- Mayo Renewable Resource Council representative noted that there may need to be
  harvesting restrictions, with a road there will be more human activity, wood from the road
  construction should be salvaged, there could be more forest fire with more human activity.

- Regional biologist indicated that there are 4 studies underway: fall moose, caribou habitat (some caribou collared in Rackla R area), wetlands mapping and fisheries (trout survey at Kathleen Lakes.
- Yukon Geological Survey will do mineral potential studies both surficial and bedrock analysis.
- There is Dolly Varden (char) in the watershed
- There is salmon in watershed
- Future activities in other areas will an impact on this area.
- Moose are down 33% in 15 years
- Consider harvest restrictions
- Important calving area
- Road will bring in more hunters
- Why is there not a staking moratorium while the Parties are developing this Beaver River Land Use Plan?
- There was discussion about Airships rather than access roads as an option.
- Attendees want to know more about airships.
- There was concerns expressed that the road was staked as mining claims rather than identified as a road: there was a question if this was legal.
- A comprehensive road feasibility study should have been done before the road was permitted.
- Concern there is a road permitted before a plan.
- Usually it would be just for a winter road
- How does Barrick Gold pulling out of the area east of the Tiger deposit impact the road/did Barrick pull out because of no access?

## The facilitators asked the attendees to share one word about the Beaver River. The following are the results of the roundtable comments:

- Pristine, Moose, Clean water no road.
- Untouched
- Healthy
- Unique
- Wetlands both sides of the river
- Moose feed along rivers if the wetlands were destroyed the moose and beaver could disappear.
- Economic opportunity
- Road destruction
