Terms and conditions

Definitions:

BEV – Battery electric vehicle. Must be powered exclusively by a battery and electric motor with no back-up internal combustion engine.

Electric cargo bicycle – Have an extended frame designed to carry goods or people.

km/h – kilometre per hour

kWh – kilowatt-hour

MSRP – Manufacturer Suggested Retail Price

PHEV – Plug-in Hybrid Electric Vehicle is powered by a battery and electric motor with a back-up internal combustion engine.

W - Watt

ZEV – Zero Emission Vehicle. ZEVs have the potential to operate without producing direct tailpipe emissions. Vehicle models may still have a conventional internal combustion engine, but must also be able to operate without it.

Eligible applicants: Businesses and non-profit organizations registered in Yukon; Yukon municipalities, First Nation governments; and Yukon residents. The Government of Yukon and federal government entities, including crown corporations, are ineligible. Yukon residency is proven by providing a copy of a Yukon driver's license or one eligible document from Yukon's [residency document list](#).

Eligibility: Zero emission vehicles, electric motorcycles, zero emission snowmobiles, electric bicycles and cargo electric bicycles must be purchased new. Used zero emission vehicles are only eligible for a shipping rebate. Purchases must occur on or after July 1, 2020 and rebate applications must be submitted to the Energy Branch within one year of date of purchase.

New zero emission vehicles must:

- Be an eligible technology: battery electric, hydrogen fuel cell, long-range plug-in hybrid electric vehicles (battery capacity of 15 kWh or greater), or short-range plug-in hybrid electric vehicles (battery capacity less than 15 kWh);
- Have a trim MSRP below \$55,000, (excludes add-ons, accessories and other fees); and
- If purchased out of territory, the vehicle must be registered in Yukon.

Used zero emission vehicles must be:

- An eligible technology: battery electric, hydrogen fuel cell, plug-in hybrid electric vehicles;
- Previously registered in a jurisdiction other than Yukon;
- Shipped into Yukon Territory; and
- Vehicle is registered in Yukon.

A used ZEV can only receive a shipping rebate once. A ZEV cannot be eligible for both the used ZEV shipping rebate and the new ZEV rebate.

Electric motorcycles must be:

- Powered exclusively by an electric motor and battery;
- Would require a Yukon Class 6 license;
- Has two or three wheels; and
- Registered in Yukon.

Scooters, mopeds, or equipment with maximum speed under 50 km/h are not eligible.

Zero emission snowmobiles must:

- Be an eligible technology: battery electric or hydrogen fuel cell;
- Meet all requirements under Yukon's *Motor Vehicle Act*.

Electric bicycles and electric cargo bicycles:

- Must meet requirements under Yukon's *Motor Vehicles Act*, specifically, maximum motor power output rating of 500W or less, through either pedal-assist or throttle-assist, and a max speed of 32 km/h.
- Electric-bicycles can be purchased in Yukon or online.

Not eligible are:

- Electric conversion kits.
- Electric motorbikes without pedals.
- Full suspension electric-bicycles designed exclusively for mountain biking.
- Bicycles purchased on crowd-funding campaign websites, such as Kickstarter, or Indiegogo.

The rebate will be calculated based on the cost of the electric bicycle or cargo electric bicycle only, and exclude the cost of accessories, shipping, assembly, etc.

Quantity: For all Good Energy transportation rebates, businesses and organizations registered in Yukon, municipalities and First Nations governments may purchase up to 10 units of each rebate type per calendar year. Yukon residents may receive up to two units of each rebate type over the lifespan of the program.

Receipts and invoices: Receipts and invoices must be legible, itemized and include: purchase date, purchaser name, retailer/supplier name, brands and model numbers of items purchased, description and cost. Where applicable, supplied invoices must include the applicant's name on this form. **Each and all invoices must have a zero balance owing or be noted as "paid in full" and initialed by the supplier.** Payment will be made to the individual or business identified on this form.

Limits to program: The Good Energy program is renewed annually pending fiscal year budget allocation. **This program is effective from April 1, 2020 to March 31, 2021.** Rebate offers are subject to program funding and revision and may change or end at any time. In no event will a rebate amount exceed the product, project or service value

Submission and payment: The Government of Yukon is not responsible for lost, late, incomplete or ineligible submissions. Allow up to 12 weeks for payment. Payment may be direct deposit if you have been employed or under contract with the Government of Yukon.

Qualifying products: The Government of Yukon's Energy Branch relies on third-party standards to identify and validate energy efficient products, projects and services.
