

# Preventing workplace violence and harassment engagement survey

Currently, Yukon does not have a territorial health and safety regulation in place that specifically aims to prevent violence and harassment in the workplace. Ours is one of the last jurisdictions in Canada to have such preventive measures in legislation or regulation.

The Government of Yukon is preparing a new regulation to prevent workplace violence and harassment. As well, the Occupational Health and Safety Regulations will see a related amendment designed to improve workplace hazard assessments.

Input from stakeholders and the public will help to ensure the specific context of Yukon workplaces is taken into account and make this regulation as effective and workable as possible.
