Subsection 2(3) of the Settlement Land Regulation provides that this Application must be accompanied by a document, made in accordance with the constitution and laws of the eligible Yukon First Nation, authorizing the application or authorizing the person or body with executive or governing authority under the constitution and laws of the First Nation to make the application on behalf of the eligible Yukon First Nation, and a plan of survey for the land made in accordance with section 68 of the Act.

The document referred to may be a copy of the original document if certified as a true copy by an official of the eligible Yukon First Nation or whoever is the custodian of the original document.

<u>TYPES OF TITLE</u>
1. Category "A" Settlement Land - equivalent to fee simple title, excepting the Mines and Minerals and the Right to Work the Mines and Minerals (paragraph 5.4.1.1(a) of the Final Agreement), or
2. Category "A" Settlement Land - fee simple title in the Mines and Minerals and the Right to Work the Mines and Minerals (paragraph 5.4.1.1(b) of the Final Agreement), or
3. Category "B" Settlement Land - equivalent to fee simple reserving therefrom the Mines and Minerals and Right to Work the Mines and Minerals, but including the Specified Substances Right (section 5.4.1.2 of the Final Agreement), or
4. Fee Simple Title reserving therefrom the Mines and Minerals and the Right to Work the Mines and Minerals but including the Specified Substances Right (section 5.10.1 of the Final Agreement).
