**Re: Kaiya Sandra Faith STONE-KIRK**

Dear Ms. KAYSEAS:

Please find attached the Inquest Report into the death of **Kaiya Sandra Faith STONE-KIRK**, which includes the comments from the Presiding Coroner, Mara POLLOCK.

Please be advised that this report and its recommendations has been posted on the Yukon Coroners' Service public web.

I would like to draw your attention to the Jury's Recommendations directed to Family and Children's Services:

- Develop a safe sleep practice policy that:
  - Includes up to date information;
  - Explains the reasoning behind various safe sleep practices;
  - Mandates that safe sleep practices information is provided each and every time Family and Children's Services is involved in facilitating the provision of resources, support or financial payment to people who provide short-term or overnight care for infants;
  - Mandates that regional offices maintain a sufficient stock of Health Canada approved safe sleep equipment for use when required;
  - Informs Family and Children's Services employees of the importance of communicating in a manner that takes into account the principles of harm reduction and trauma-informed communication.

- Develop and incorporate policies respecting the stock of safe sleep equipment including:
  - staff review and understanding of owners' manuals;
  - staff understanding of the appropriate use of equipment in consideration of the infant's age, size, and weight;
  - owners' manuals are provided to the caregiver when equipment is loaned;
  - copies of owners' manuals are maintained at the regional office.
- Provide mandatory in-person training on the safe sleep policy every two years for Family and Children's Services employees. This training must be developed using the principles of cultural safety, harm reduction, and trauma-informed communication and should include demonstrations on how to set up safe sleep spaces.
- Create clear policies that apply to Extended Family Care Agreements. These policies should ensure that Extended Family Care Agreement families have a safety plan in place for short-term urgent situations. These policies must outline the roles and responsibilities of Family and Children's Services, extended family caregivers, and people who provide short-term or overnight care for infants.
- Develop a course in collaboration with First Nations that must be completed by every person who is paid by Family and Children's Services to provide short-term or overnight care for infants. This course must include education on safe sleep practices and must be developed using the principles of cultural safety, harm reduction, and trauma-informed communication.
- With a priority for Liard First Nations and Watson Lake, in collaboration with First Nations develop a roster of people in each community that can be relied upon to provide short term or overnight care for infants and children, when a caregiver is in urgent need of such services.
- With a priority for Liard First Nation, support First Nations in the establishment of resources in their communities for the temporary care, including overnight stays, of infants and children in emergency situations

I ask that a response setting out intentions with respect to these Recommendation be received by **October 18, 2023**. Pursuant to Section 5(1)(o) of the *Coroner's Act*, this letter and any response or lack of response to the recommendations will be made public.
