



Update for Government of Yukon Retirees

Changes to your Group Insurance Benefits Plan, effective April 1, 2022

New premium rates for the Extended Health Care insurance plan will be in effect as of April 1, 2022. Extended Health Care premium rates are adjusted each year to reflect changes in the member group's demographics, use of the benefit plan, cost of medical supplies and services as well as the insurer's expenses.

The Extended Health Care rates will decrease by 8% for April 1, 2022. In addition to premium rate changes, other approved changes include increasing the annual psychological maximum to \$1,200 per benefit year (April 1 to March 31) and eliminating the doctor's prescription requirement for massage therapy.

The changes below are effective April 1, 2022 and affect both the employer and retiree contributions.

The change to premium rates will be reflected on your April 2022 Electronic Funds Transfer (EFT) from your bank account.

The employer/retiree share of the premium is based on years of continuous service prior to retirement.
