Family Income¹ of Taxfilers, 2019

Released by Statistics Canada — July 15, 2021

In Yukon, the median total income for families for the 2019 tax year was \$114,450. Yukon ranked the second-highest in the country following the Northwest Territories (\$125,070). Compared to 2018, Yukon's median total income for families increased by \$3,420, or 3.1%. Nationally, the median total income for families increased by \$2,740, or 3.1%, compared to 2018.

The median total income for couple families in Yukon (\$129,170) was the second-highest in the country following the Northwest Territories (\$154,830). Yukon's median income for couple families was \$30,260, or 30.6%, higher than that of Canada (\$98,910).

The median total income for lone-parent families in Yukon (\$61,130) was the highest in the country and \$9,920, or 19.4%, higher than that of Canada.

Note: Families are comprised of: 1) couples (married or common-law, including same-sex couples) living in the same dwelling with or without children, and 2) single parents (male or female) living with one or more children. Persons who are not matched to a family become persons not in census families.

² Median is the middle number in a group of numbers. Where a median income, for example, is given as \$26,000, it means that exactly half of the incomes reported are greater than or equal to \$26,000, and that the other half is less than or equal to the median amount.
