Employment Insurance, June 2022 (preliminary data)

Released by Statistics Canada – August 18, 2022

In June 2022, the preliminary number of El beneficiaries (seasonally adjusted) receiving regular income support benefits¹ in Yukon was 620; of which 380 were males and 240 were females. Compared to June 2021, the total number of beneficiaries decreased by 900, or 59.2%; compared to the May 2022 preliminary figure, the total number of beneficiaries decreased by 20, or 3.1%.

Nationally, the preliminary number of El beneficiaries (seasonally adjusted) in June 2022 decreased by 69.8% compared to June 2021 and decreased by 1.4% compared to the May 2022 preliminary figure.

Notes to Readers:

- No methodological changes were made to the Employment Insurance Statistics (EIS) program over the COVID-19 period. EIS reflect the Employment Insurance (EI) program for the Labour Force Survey (LFS) reference week in each month.
- Data for the October 2020 reference period and onward consist of individuals who obtained El benefits, and exclude beneficiaries
 of the Canada Recovery Benefits (Canada Recovery Benefit (CRB), Canada Recovery Caregiving Benefit (CRCB), and Canada
 Recovery Sickness Benefit (CRSB).
- The number of beneficiaries is a measure of all people who received regular El benefits from June 12 to 18, 2022. This period
 coincides with the reference week of the LFS.
