### **Employment Insurance, October 2023 (preliminary)**

Released by Statistics Canada – December 20, 2023

In October 2023, the preliminary number of El beneficiaries (seasonally adjusted) receiving regular income support benefits<sup>1</sup> in Yukon was 560; of which, 400 were males and 160 were females. Compared to October 2022, the total number of beneficiaries remained the same; compared to the September 2023 preliminary figure, the total number of beneficiaries decreased by 20, or 3.4%.

Nationally, the preliminary number of El beneficiaries (seasonally adjusted) in October 2023 increased by 1.5% compared to October 2022 and increased by 0.7% compared to the September 2023 preliminary figure.


