



Gross Domestic Product by Industry (GDP), 2022

Released by Statistics Canada – November 8, 2023

In 2022, Yukon's real GDP by industry (\$3,297.6 million, in chained 2017 dollars¹, at basic prices²) grew by \$179.7 million, or 5.8%, following a revised growth of 8.4% in 2021.

In 2022, Yukon's Goods-producing industries grew by 11.6%, primarily driven by the growth in the Construction sector (34.0%). The 2022 GDP in the Mining, quarrying, and oil and gas extraction sector decreased by 0.5%.

Yukon's Services-producing industries grew 3.6% in 2022. Among the Services-producing industry sectors, Accommodation and food services grew by 22.5%; followed by Transportation and warehousing (22.0%); and Arts, entertainment and recreation (8.1%).


¹ With this release, the reference year for all GDP volume and price estimates has been updated to 2017=100. Subsequent releases, including the quarterly GDP program and Capital stock program, will follow the new 2017=100 reference year.

² A basic price valuation including the costs of production factors (labour and capital) and indirect taxes and subsidies on production factors. It represents essentially the prices received by the sellers, and does not include taxes on the sales of goods and services.





In 2022, real GDP by industry grew in all provinces and territories except Newfoundland and Labrador (-1.5%). In 2022, Yukon's real GDP by industry growth (5.8%) was the second highest of all provinces and territories following Saskatchewan (6.0%).
