This report discusses the main design, methodology, and findings of the Yukon Licensed Child Care Services User Survey.

1. Background and Rationale

The purpose of the survey is to assist the department of Health and Social Services Child Care Services Unit to better understand:

- the concerns users of licensed child care services have with day care services
- the concerns users of licensed child care services have with the regulations governing child care services
- how the Child Care Services Unit can improve their services to the users of licensed child care services.

Information gathered through this survey will be used to plan for changes or improvements to the current system.

The following agencies were involved:

- Yukon Department of Health and Social Services, Child Care Services Unit
- Yukon Bureau of Statistics

2. Main Constraints

The main constraints in the design and interpretation of the Licensed Child Care Services User Survey are:

- Limited ability to generalize the results of the survey to all parents/guardians using licensed child care services. Respondents to the survey were limited to a random sampling of only those who receive a child care subsidy from the Government of Yukon (or had received a subsidy in the last fiscal year.)
- Veracity of respondent answers. Although respondents were assured confidentiality and anonymity by the interviewer, concerns over losing their subsidy or other ramifications may have made respondents a little less forthright in bringing forward their concerns with the Child Care Services Unit.

3. Data Collection Objectives

The key data collection objectives of the Licensed Child Care User Survey are as follows:

- 1. to develop a profile of licensed child care services from the users perspective:
 - reasons for selecting the type of care used
 - additional supports needed to address physical, developmental or behavioural needs
 - satisfaction with present child care arrangements
 - perception of quality of care received
 - concerns with licensed child care in Yukon
- 2. to assess the priorities of respondents regarding actions that could be taken with respect to licensed child care services
- 3. to assess the satisfaction of respondents with respect to the service received from Child Care Services Unit, and what, if anything, the unit could do to improve their service to clients.

4. Design and Operations

4.1. Questionnaire Content

The Licensed Child Care User questionnaire content follows quite closely those used in other jurisdictions. Some questions were modified to reflect Yukon priorities and the reality of living in the Yukon.

4.2 Data Collection

Telephone interviews, supplemented with face-to-face interviews where necessary, were used to collect data. Four interviewers were trained to administer the survey questionnaire. All interviews were conducted between late spring and early fall 2005. Follow-up interviews were completed in March, 2006. The interviewers' normal telephone working schedule was from 9:30 am to 9:00 pm Monday to Thursday, and from 9:30 am to 4:30 pm on Saturday. A minimum of 10 call-backs were placed to unanswered telephone numbers. In addition, many individuals who refused to participate on the first contact were re-contacted by a senior interviewer in order to maximize participation.

4.3 Participation & Sample Evaluation

A sample frame was developed from a master list of individuals receiving Child Care Subsidy from the Child Care Services Unit during the 2005-2006 period. Personal contact information including name, address and phone number were used to track randomly selected respondents. The following table provides a summary of the survey operations.

5. Summary of Findings

Summary

Who participated in the Licensed Child Care User Survey?

The majority of participants responding to the questionnaire were:

- female
- single (never married)
- had only one child in child care
- the legal guardian of the child(ren) in child care
- needed child care services during regular work hours

Utilization Profile of Licensed Child Care

Respondents were divided fairly evenly between the four types of licensed child care: Family Day Home, First Nation Day Care, For Profit Day Care, and Non Profit Day Care. Most analysis in this report was done by comparing answers from these four categories.

Only 10% of respondents said that their child needed additional support to address physical, developmental or behavioural needs. Almost all of these respondents said that these needs for support were currently being met (the most common additional support required was for speech therapy).

Over four-fifths of all respondents said they chose the particular type of care that they did because 1) the overall quality of service provided was good; 2) the hours of operation met their needs; 3) the location of the operation was convenient; and 4) there was space available.

Almost all (90%) of the respondents said that they were satisfied with their present child care arrangements; and three fourths indicated satisfaction with the amount they paid for these arrangements. Concerns in these areas included: poor quality of care, staffing issues, programming at the child care centre, having to pay twice during closures/vacations, the amount required to pay 'out of pocket', and the cost effectiveness of working and being on the program.

Respondents Priorities for Action

When asked to examine the quality of care that their child received, one-third of all respondents indicated that in the past year they had been concerned that their child was getting sick as a result of being in child care. Nearly the same amount had been concerned that the regular activities or programming for the children was limited. Other concerns raised included: qualification/training of staff, proper supervision of children, the value of working when child care costs are so high, the level of government support received, and wage of child care workers.

After identifying areas that needed attention, respondents then selected actions that they felt should be taken to help improve the licensed child care services program. Respondents assigned high levels of importance to: increasing funding for children with special needs, assistance in recruitment/training/retention of child care workers, decreasing the cost for low income families, and increasing the wage of child care providers.

Respondents Review of Child Care Services Unit

In general, most respondents indicated overall agreement with statements describing their satisfaction with different aspects of the service received from the Child Care Services unit. The highest level of agreement was with the statement "Overall, I am treated fairly by the Child Care Services Unit", and the least was with the statement "Staff go the extra mile to help me get what I need'.

About a quarter of the respondents indicated that there was nothing that the Unit could do to improve its service to them. The remaining three-fourths' suggestions included the following themes: improve the quality of service, broaden the 'income/means' test, make the service more understandable, don't cut off subsidy so quickly while taking so long to approve, increase the amount of subsidy, increase support to the industry, and improve Unit monitoring/inspection.

Along the same lines, those who reported experiencing problems with the Unit (15%) had the following issues: staff are poorly organized and provide conflicting information, staff complicate an already frustrating application process, program policies penalize clients, staff do not act in a professional manner, the complexity of the program creates difficulty for all involved, and the program is weak in enforcement.

6. Detailed Findings

6.1 Profile of Respondents to Licensed Child Care Services User Survey

Demographic Information

Of the 321 people who responded to the workshop survey, the majority were:

- Single (never married), 49%
- The legal guardian of the child, 98%

After 'single (never married)', the most common responses were: 'married' (17%), 'separated' (15%), 'common-law' (14%), 'divorced' (4%), and 'widowed' (1%).

6.2 Licensed Child Care Services User Survey - Data Summary

Details

Utilization Profile of Licensed Child Care

Type of licensed child care chosen

Clients were asked which type of licensed child care they chose to put their child(ren) in. Their answers were split somewhat evenly, with 30% of all respondents selecting 'For Profit Day Care', 30% selecting 'Non-Profit Day Care', 25% selecting 'Family Day Home' and 13% selecting 'First Nation Day Care'.

Number of children in licensed child care

Slightly over half of all respondents, 59%, indicated that they had only one child in licensed child care. Another third, 35%, indicated that they had two children in child care. The remaining respondents, 6%, reported more than two children in child care.

Of those respondents with multiple children in child care, 6 respondents reported that each of their two children were in a different type of licensed child care.

Additional support needed

When asked if their child required additional support, 10% of respondents said "Yes". Of these, the most commonly reported need was for speech therapy, 47%; the next closest being support for behavioural needs, 14%; and support for development needs, 12%. Almost all respondents with children requiring additional support, 92%, felt that these needs were currently being met.

Reasons for selecting the type of care you presently use

Respondents were provided with a list of statements describing reasons for selecting the type of care they presently use and were asked to indicate if any of the given statements was a factor in their decision on the type of care they chose. Following is a list of the percentage of respondents agreeing with each particular reason:

- the overall quality of service provided was good, 87%
- the hours of operation met my needs, 86%
- the location of the operation was convenient, 85%
- there was space available, 84%
- the cost was reasonable, 63%
- it offered needed specific programs or services, 53%
- other reasons, 44%

The most common reasons provided by clients of Family Day Homes were:

- the overall quality of service provided was good, 91%
- there was space available, 89%
- the hours of operation met my needs, 87%

The most common reasons provided by clients of First Nation Day Care were:

- the location of the operation was convenient, 88%
- the overall quality of service provided was good, 81%
- there was space available, 81%

The most common reasons provided by clients of For Profit Day Care were:

- the hours of operation met my needs, 87%
- the location of the operation was convenient, 86%
- the overall quality of service provided was good, 85%

The most common reasons provided by clients of Non Profit Day Care were:

- the overall quality of service provided was good, 88%
- the location of the operation was convenient, 86%
- the hours of operation met my needs, 86%

When asked "Of the reasons you've provided, which one would you say is the most important reason in selecting the type of care that you have?", the most common reasons selected were:

- the overall quality of service provided was good, 37%
- other reasons, 22%
- the location of the operation was convenient, 17%

Hours typically required for child care services

Respondents were asked to choose from a list all times that they typically required child care services. Almost all, 78%, said they needed child care during regular work hours (e.g. 8:30 a.m. to 5:00 p.m.). 15% said 'other times', 4% said 'weekends/holidays' and 3% said 'shift work'.

The most common specifications from all respondents for 'other times' were:

- after school care, 39%
- during school hours, 19%
- part time care (e.g. a couple of hours for a couple of days a week), 18%

The most common times provided by clients of Family Day Homes were,

- during regular work hours, 70%
- other times, 18%
- weekends/holidays, 8%

The most common times provided by clients of First Nation Day care were,

- during regular work hours, 87%
- other times, 15%
- shift work, 4%

The most common times provided by clients of For Profit Day Care were,

- during regular work hours, 79%
- other times, 15%
- weekends/holidays, 4%

The most common times provided by clients of Non Profit Day Care were,

during regular work hours, 80%

- other times, 16%
- weekends/holidays, 3%

Satisfaction with present child care arrangements

Respondents were asked if, overall, they were satisfied with their present child care arrangements. Of all the respondents, 90% said 'yes' and 10% said 'no'.

Responses provided by clients of Family Day Homes were,

- yes, 92%
- no, 8%

Responses provided by clients of First Nation Day Care were,

- yes, 90%
- no, 10%

Responses provided by clients of For Profit Day Care were,

- yes, 90%
- no, 10%

Responses provided by clients of Non Profit Day Care were,

- yes, 87%
- no, 13%

The most common reasons given for why the clients were satisfied were:

- meets my needs, 31%
- quality of care is good, 22%
- it is convenient, 19%

The most common reasons given for why the clients were not satisfied were:

- quality of care is poor, 33%
- staff are unreliable, high turnover, little training, 23%
- little age-specific programs/activities, 14%

Cost of present child care arrangements

Respondents were asked if, overall, they felt that they paid too much for their present child care arrangements. Of all the respondents, 24% said 'yes' and 76% said 'no'. There were some noteworthy differences in the responses between those who utilized different types of licensed child care:

Responses provided by clients of Family Day Homes were:

yes, 26%

no, 74%

Responses provided by clients of First Nation Day Care were:

- yes, 9%
- no, 91%

Responses provided by clients of For Profit Day Care were:

- ves, 22%
- no, 78%

Responses provided by clients of Non Profit Day Care were:

- yes, 31%
- no, 69%

Some responses given for why the clients felt they paid too much for child care were:

- a reflection of their current financial situation—they are on a limited/fixed income, paying for some of the costs 'out of pocket' even though they were able to meet the Child Services Unit 'means' test for subsidy
- questioning the amount of the subsidy and/or the 'means' test and continued application
- indicating that without the subsidy they would be better off staying at home with the children
- concerns with how child care services were priced—i.e. what is included or not included
 in the price (i.e. food, activities and part-time being priced as full-time)

Respondents' Priorities for Action

Concerns about the Quality of Care Received

Respondents were asked if, in the last 12 months, they had ever been concerned with any of the following quality of care issues:

- Staff are working without proper qualification or training, 18%
- Regular activities or programming for the children are limited, 28%
- Accidents or injuries to your child go unreported, 12%
- Your child is not receiving proper nutrition, 6%
- Your child is not being properly supervised, 15%
- Your child is getting sick from being in care, 33%
- Your child may be at risk of harm by being in care, 9%

Furthermore, 30% of respondents indicated that they had other concerns that they would like to raise about licensed child care. These included:

• the high cost of day care relative to what parents made; many questioned the value of going to work, paying up to ½ of their monthly income on day care when it would make better financial sense to not go to work and live off welfare

- questions on how day care service is priced and the fairness of having to pay double the amount for day care – once to the regular day care (when the primary care centre is closed for summer/holidays), and again to the other day care that the children have to go to
- call for child care providers to get more support financially and otherwise from government and increase the number of spaces available, especially for babies and younger children
- call for child care workers to receive a fair wage to reflect a minimum standard of training; and compensation to reflect the value of ongoing training
- question of the unevenness in the quality of programming, activities and facilities offered by different day cares and the need for more, and better trained, staff
- question the level of monitoring/inspection/investigation by Child Care Services Unit to ensure quality of service; more transparency when complaints are made or charges laid; and better background checks on day care workers

Actions that could be taken with respect licensed child care services

Respondents were asked to rate how important the following actions were with respect to licensed child care services. Responses included:

- Increase the number of licensed child care spaces in my community
- Increase the quality of the programs offered by licensed child care services
- Increase funding for children with special needs
- Decrease the cost of licensed child care services for low-income families
- Assist in the recruitment, training and retention of child care workers
- Support the use of community schools by child care programs or after school programs
- Improve the enforcement of existing regulations governing licensed child care
- Increase the wages of child care providers

Over two-thirds of respondents gave a rating of "5", that is they felt that it was very important to:

- Increase funding for children with special needs, 73%
- Assist in the recruitment, training and retention of child care workers, 68%
- Decrease the cost of licensed child care services for low income families, 67%

When asked "Of the actions you gave a rating of "5" to, which one action do you feel is the most important?" the top three selected actions were:

- Increase the wages of child care providers, 24%
- Decrease the cost of licensed child care services for low income families, 20%
- Assist in the recruitment, training and retention of child care workers, 12%;

Respondents Review of Child Care Services Unit

Satisfaction Rating

In general, most respondents indicate overall agreement with a given set of statements describing their satisfaction with different aspects of the service received from the Child Care Services unit. The highest level of agreement was with the statement "Overall, I am treated fairly by the Child Care Services Unit", and the least was with the statement "Staff go the extra mile to help me get what I need'

Respondents indicated 'agree' or 'strongly agree' by answering '4' or '5' to their level of agreement with the following statements about the unit:

- Overall, I am treated fairly by the Child Care Services unit, 86%
- The unit provides its service in an open and accountable manner, 82%
- Staff are knowledgeable and competent, 79%
- Overall, I am satisfied with the amount of time it takes to get the service I need, 76%
- Staff are courteous, 75%
- Staff go the extra mile to help me get what I need, 70%

Responding clients with children in care in Family Day Homes indicated agreement with the statements:

- Staff go the extra mile to help me get what I need, 65%
- Overall, I am satisfied with the amount of time it takes to get the service I need, 76%

Clients with children in care in First Nation Day Cares indicated agreement with the statements:

- Staff go the extra mile to help me get what I need, 76%
- Staff are knowledgeable and competent, 88%
- The unit provides its service in an open and accountable manner, 88%

Clients with children in care in For Profit Day Cares indicated agreement with the statement:

- Staff go the extra mile to help me get what I need, 75%
- Staff are knowledgeable and competent, 81%
- Overall, I am satisfied with the amount of time it takes to get the service I need, 82%

Clients with children in care in Non Profit Day Cares indicated agreement with the statement:

- Staff go the extra mile to help me get what I need, 68%
- Overall, I am satisfied with the amount of time it takes to get the service I need, 68%
- Staff are knowledgeable and competent, 74%

Suggestions for Improvement

When asked "What can the Unit do to improve their service for you?" 23% responded 'nothing'. Others had comments which are summarized in the following categories:

Improve the quality of service, 16%

- Broaden the 'income/means' test to take more factors into consideration, 15%
- Make the service more understandable, 12%
- Don't be so quick to cut off subsidy, and don't take so long to approve, 11%
- Increase the amount of the subsidy, 8%
- Increase the support to industry to increase the number of spaces, 8%
- Improve the Unit's monitoring/inspection of licensed day cares, 6%

Problems experienced using the services of Child Care Services unit

Overall, 15% of respondents reported experiencing problems using the Child Care Services unit. The most common problems these respondents reported are summarized below:

- Program policies penalize clients, 16%
- Staff are poorly organized and provide conflicting information, 25%
- Staff complicate an already frustrating application process, 22%
- Staff do not act in a professional manner, 11%
- Complexity of the program creates difficulty for both staff and clients, 10%
- Program is weak in enforcement, 3%

- 1131 I find the care very marginal. This particular program doesn't provide any snacks or food. As a single parent I don't seem to be getting any full support from the child care.
- 1302 Sometimes when I have gone to the day care to drop off my child she is not there and I have to wait for her. If I get angry with her about this she will yell at me. She also closes for the summer and holidays.
- 1456 The child care provider's lack of responsibilities to the children.
- 1420 The hours at the day care need to be extended.
- 1318 The quality of care is below standard.
- 1249 When the day care was taken over they didn't take the children out much on walks. They also did not break the children up according to age groups and do different activities with them so my son was unhappy

First Nation Day Care Clients

- 1034 It is expensive, not reliable and there are on other child care options in this area
- 1270 The cost is too high
- 1315 The day care had shut down at this time and the quality of the day care was between average and poor.
- 1107 They are not open at lunch time. I have to leave work to go and pick him up. And they are not open in the summer.

For Profit Day Care Clients

- 1367 Did not think the overall quality was very good. There was no routine or structure.
- 1398 I don't have him in day care right now.
- 1151 I don't like the location of the day care. It's not too far from the liquor store and the bar. They should relocate the day care to somewhere safe.
- 1135 I'm not happy with the ratio of children to workers. There needs to be more child care workers.
- 1334 Staff turn over rate is very high, and it is not very clean.
- 1427 Staff turnover is quite high. With the exception of the nursery room, I am not impressed with the rest of the day care.
- 1073 The day care doesn't have specific criteria/programs in place, it seems to just be a "free for all". Some staff think that some children should be more advanced than they really are, therefore they expect them to be able to do things they are not capable of. There are no

specific/designated areas (other than the baby room) for the different ages. For example, my 18-month-old and 3-year-old are in the same play areas as the school age children, because of this they are learning language (swearing) and behaviour (hitting, pushing) that they shouldn't be learning at this age. There should be separate areas for preschool and school age children as well as the baby room they currently have.

1086 The quality of the day care is poor overall, with programs and supervision.

Non Profit Day Care Clients

- 1171 At my daughter's day home she was exposed to the wrong type of shows on television. The day care provider was yelling at her teenage daughters in front of the kids too. I therefore pulled her out of this care.
- 1371 He's not in day care right now.
- 1243 I am concerned about the high turnaround of staff
- 1348 My child can't talk too good and he is two years old. I don't know what happened, but he is not happy there and he doesn't want to go there.
- 1002 My child was not stimulated enough at day care as he was left without any activities. He was even complaining and his behaviour was worse. We ended up leaving the day care.
- 1356 My kids are 8 and 11 years old and they need activities for their age group.
- 1105 People had no training, no stability. The management had trouble keeping people.
- 1179 The price is too expensive.
- 1245 There is a big change of educators all the time, and it is hard to get educators in French. Therefore there is no stability.
- 1221 There is no day care open early and I would like to see day cares open earlier.
- 1043 There is no structural programming where my son is. They just watch him but he is loved there.
- 1118 They are understaffed; younger children need a regular routine, someone who will be there all the time.
- 1111 They need better programs and activities for the children. More structure and a routine.

Q7.1 If YES, Why do you feel you pay too much?

Family Day Home Clients

- 1164 As a single parent I have to pay so much.
- 1302 Because \$500/month is too much when I also have to pay for rent and food. All my money is gone and I have no money for extra expenses.
- 1335 Because I am on a low income. I find it costly.
- 1322 Because I have to pay extra.
- 1131 Because the cost is too much to afford right now. The government is not user friendly and the child support shouldn't be calculated as part of your income.
- 1106 Being a single parent I find it hard sometimes to make the payment.
- 1244 Child care is expensive in general.
- 1428 Half of my pay cheque goes to day care as I am not eligible for subsidy.
- 1074 I receive a subsidy but I still have to pay a portion and I find it hard when I am on a low income budget.
- 1089 If I did not have a subsidy then it would not be worth putting my child in day care. I would be better off staying at home.
- 1206 If I make a certain dollar amount they don't consider my bills and my rent.
- 1240 It costs a lot of money for only 1.5 hrs 5 days a week. The holiday rates are raised. During spring break I had to pay an extra \$100.00.
- 1186 It gets expensive and harder
- 1060 It's a bit high, but it is worth it because the service is good.
- 1449 It's a lot for a single parent with only one income.
- 1374 It's around \$1200/month for all three of my children.
- 1156 My child goes part time (2 hours a day) and I think I pay too much for child care.
- 1249 My son didn't go to day care in December but I had to pay the full amount just to hold his spot
- 1304 The second day care cost more than the first day care.

First Nation Day Care Clients

- 1256 Because I can't seem to get ahead.
- 1034 I can't afford it
- 1168 It's just too much to afford right now.
- 1270 When I work, the parent contribution goes up
- 1065 Because I am on a limited low income.

For Profit Day Care Clients

- 1151 Because I have to pay other bills and groceries are expensive. I think that parents on income support shouldn't have to pay so much for day care.
- 1015 Because child care is a necessity and should be a basic right.
- 1135 Because there are not enough child care workers to cater for my child.
- 1334 Child care is expensive in general.
- 1219 I am a low-income student and I pay an extra \$50 more. The day care rates went up this year and it makes a big difference for me.
- 1281 I am a struggling student and I find it tight on my budget.
- 1291 I am working part time and half of my paycheque goes to child care.
- 1341 I pay \$575.00 for one child in child care. She goes Monday Friday 9:00 AM 4:00 PM.
- 1209 I pay an extra \$100/month and they are not always there because of my schedule. The extra \$100 can go towards food because I am a single parent.
- 1325 I pay an extra seventy-five dollars and still have to provide lunch. Some day cares are less and they also provide lunch.
- 1012 If I didn't get the subsidy, I don't think I could afford it.
- 1067 It is hard for two working parents to afford child care. Even with the subsidy, there is still a lot to make up.
- 1073 The cost does not include meals, snacks, diapers or extra activities such as swimming. In the day cares I've used previously this was all included in the day care cost.
- 1134 The price range between toddlers and 3-year-olds are not different. It is kind of expensive.
- 1071 They don't provide food and my children are only there part time.

- 1220 They took away my subsidy and I couldn't afford day care.
- 1218 We pay close to \$500.00 per month. We don't qualify for subsidy and we are right on the borderline.
- 1367 Well, I have subsidy to pay for most of it, but I had to pay for them to pick up my children from school. I thought they could at least include that already in the pay, not be something extra.

Non Profit Day Care Clients

- 1429 All child care is expensive.
- 1093 All child care seems really high in general.
- 1204 Because I am on low earnings during the winter time, so it is expensive.
- 1027 Because I don't see where my money is going. They seem to always be complaining about a lack of supplies.
- 1277 Because after you pay for child care, you don't have much left for anything else.
- 1179 Because the price is too high.
- 1266 Because when I take on a new job that will push me into a higher income bracket and I will not be eligible for subsidy.
- 1150 Because with four kids in the day care I have to pay extra money.
- 1408 Day care cost is more than our mortgage payment.
- 1046 Everyone pays too much. Half of my paycheque goes to child care.
- 1105 For the quality of service provided it was too high.
- 1139 Having to pay extra money for 2 children was too much to afford and I was going to school at the time.
- 1192 I am a single parent and I don't qualify for subsidy.
- 1359 I am a single parent and my subsidy changes every 6 months. The prices have gone up for child care and it is getting harder for me.
- 1221 I am a single parent, even though I work for the government. I don't always get my maintenance money on time too.
- 1245 I don't have a high income and the rate is really expensive.
- 1202 I don't need the day care all the time. My understanding is that I will not qualify for subsidy for drop-ins.
- 1229 I pay too much and I feel that subsidy should adjust to my income. I shouldn't pay too much out of my pocket.

- 1079 I think I am paying more than I should pay as I am not earning as much as I used to.
- 1375 It is a big chunk of your monthly income when you don't make that much.
- 1059 It is too high and over the Christmas holidays and spring break there was a big increase in cost even when we were not using the service
- 1178 It was expensive having 2 children in child care.
- 1076 It's reasonable, but it could still be cheaper.
- 1118 My daughter goes to school and then goes to the day care for only 45 minutes to an hour. I still have to pay as though she was there full time.
- 1237 My son goes to day care only after school and I pick him up at 5:30 PM. I pay \$575.00/month for only part-time attendance and I am a single mother.
- 1392 My son is there for 2 hours a day and I have to pay a large amount every month.
- 1451 They take my gross income and I don't make much money.
- 1396 We are on subsidy and they have classified me as a full-time worker only because I work two hours too many. Anything over 20 hours is considered full-time, so we receive less subsidy. I have to pay the parental portion as if my children are going full-time, not part-time like they are. My extra two hours of work does not even cover the extra I have to pay.
- 1018 Yes, because I have extra out of pocket expenses but it is not enough to pay child care workers adequately.

Q9.1 If YES, What are these other concerns you would like to raise about licensed child care?

Family Day Home Clients

1175 Before this day home I've realized that some day cares don't offer as much to the kids.

1030 Child care providers should get more support from child care services.

1119 Child care workers should receive a lot more support from the government, higher pay and better hours.

1077 I believe that child care workers should be paid more and have more support from the government, with funding.

1302 I do not think it is fair that if the day care closes for the summer or holidays that I should still have to pay them for that time. This means I have to pay double the amount for day care, \$500/month to the closed day care and \$500/month to the other daycare that my child has to go to when our regular day care is closed. This is not right or fair. Also, there should be more places that are open in the evenings.

1144 I feel there's too much TV exposure and in the winter they are not outside a lot.

1307 I think day homes and day cares are under funded.

1019 I think the child care subsidy should be raised. I only get \$450 per child. The cost of child care is going up but the subsidy is not.

1248 I used to work at Maranatha Play School and there was a lady there that was very physical with the children. It was reported to the director who did nothing. The person was fired only when Child Care Services got involved. There needs to be more monitoring of child care centres and their directors.

1186 I would like to see a child care facility at Marsh Lake

1420 I'm concerned that there are too much children in this day care.

1153 In the past, the costs were quite expensive.

1457 It costs too much for day care. It costs less not to go to work and to live on welfare. The price of day care is outrageous.

1333 It would be good to have higher subsidy rates or lower day care rates

1257 My present child care should go to some upgrade because they have been around for so long. My child bit another child and the care worker bit him back which is not appropriate.

- 1289 Not enough available day cares who offer care for people who do shift work at nights.
- 1339 The last day home had too many children and less staff. This is not good, a child could get hurt.
- 1194 The turnover of staff is too high because they don't get paid enough.
- 1436 There is a lack of communication between the school and the day care. The day care was closed once and the bus dropped my son off and he was locked out. There are no emergency plans in place.
- 1054 There should be better watchdogs on individual day homes. In a day care my daughter was in previously there was a lot of neglect. One child was locked in a "time-out" room for two hours and they forgot about him.
- 1280 They need to have more child care service workers coming to visit periodically, maybe every two weeks, to ensure good service.
- 1201 We need more child care spaces.

First Nation Day Care Clients

- 1382 Child care workers are not being paid enough.
- 1462 Have more qualified child care workers. The child care facilities should have a routine and structure. Children should not be watching T.V. at day cares all day.
- 1411 I just want to know whether day cares get inspected on a yearly basis.
- 1133 I wanted to know if there is a policy for general day care because there was a dog at the day care and I don't think there should have been one there.
- 1168 My child gets sick too much and this concerns me.
- 1409 The ratio of care workers to children should be lower.
- 1323 The workers need to pay more attention to the children. They are responsible for them.
- 1034 There should be more subsidy
- 1265 This child care closes every summer and I would like to know why. They need more back up as they have to close when they are short on staff.
- 1439 We need more qualified child care staff. They need to do more early childhood classes.

For Profit Day Care Clients

- 1053 Child care facilities need more staff. The kids need to be watched more so as there will be less bumping, bruising and biting.
- 1233 Child care workers are not being paid enough.

- 1124 Child care workers aren't being paid enough and they need more training in child care.
- 1434 Child care workers do not get paid enough for the amount of work that they do.
- 1086 Good quality is an urgent need in day cares. There needs to be more care givers per child. We need to recognize that care givers are raising our children. The need to be more like good parents.
- 1001 Greater than 12 months ago there was a bad situation at a day home where a worker was caught in possession of pornography. The whole situation was not handled well even after the arrest. The authorities did not supervise the day home and deal with the emotional instability generated there.
- 1331 Have schools introduce after school care and day cares can fill their space for younger children.
- 1357 I don't think day home providers should be able to open and operate without a level one. A level one is not enough to open a day home. They should have a level three to open a day care.
- 1116 I feel that child care workers are under paid. They are raising our future generations. If they were paid more they might put in more effort.
- 1182 I had problems at Love to Learn. My daughter had a terrible diaper rash where she was bleeding. I do not feel the babies were supervised well, as my child was being harmed by other children (bully kids). One woman should not have been with babies. She would scream at them. Even after complaining, she still worked in the baby room to cover breaks. She was way too stressed to work with babies. This day care never really had a good sleeping room and I would find my daughter sleeping in play area because they said she would not go in the nap room because another child was sleeping already.
- 1061 I think that it should be more regulated for safety issues.
- 1282 I think that there should be more day cares that provide night watching for those people that work shifts.
- $1278\ \text{I}$ want to know why I have ended up paying more here in Whitehorse for day care than I did in Ross River.
- 1151 I'm concerned about the cost I have to pay for day care and the location of the day care is unsafe.
- $1332\ \text{It}$ would be good if more day care providers offered a program for babies and younger children
- 1224 Lack of child care facilities in the Yukon. They need to have at least one in every community.
- 1325 Maranatha does not give permission slips when going out of the day care. They always go to the park or the pool and they never let me know. I find out from my child.
- 1065 More funding for day homes.
- 1205 The Church of Nazarene Day Care had never wiped my children's noses because they were dirty every time I went there.

- 1225 The child care providers do not get paid enough.
- 1401 The cut-off date for subsidy should be extended.
- 1383 The ratio of children to care givers is too high. Right now it is 12 to 1.
- 1015 The system needs more money so it can do what the education system does.
- 1135 The workers qualifications need to be higher (perhaps degree qualified). An increase in wages would follow as the job would be recognized as a profession.
- 1066 There is not enough funding for activities for the children.
- 1200 There should be more day cares with well paid staff.
- 1029 They should be measured against the top child care services (or the more successful ones). They should monitor child care workers more as I have heard reports of children being served rotten milk.
- 1155 They should have information on all of the staff members, so parents will know information about them.
- 1367 We need to make sure that there are more qualified day cares. Increase the regulations over day cares, or at least make sure that they are being met.
- 1260 When my sister was going to day care there was no reading, learning or math. The day care only did arts/crafts and she was in grade 1.

Non Profit Day Care Clients

- 1018 Better background checks for staff are needed and more transparency when a child care worker is charged with an offence.
- 1043 Child care workers are paid so little (often \$9 per hour) so there is high turnover.
- 1171 Day homes should be checked more often.
- 1118 I don't think paying full time prices for children that only go to the day care is fair.
- 1298 I think that Level 1 in Child Development should be a requirement in the hiring process of workers, not just hiring them and then training the workers as they go.
- 1451 I think that day cares are under staffed.
- 1103 I think that other day cares should follow programs and stick to them, like schedules.
- 1306 I think that parents should have more involvement with the day care programs and volunteering. They should have opinions on what kind of program or services they would like to see in the day cares.
- 1446 I think there should be stricter monitoring of child care centres.
- 1237 I think they should find more information on their child care workers. There was an ex-drug user working in the day care and when she touches my child

- it goes into his system. I got her fired. I am afraid it could be happening in other child care facilities.
- 1371 I think they should have cameras in the day cares in case something should happen. This will show them proof of what happened.
- 1027 I would like to see a bit more investigation into the background of child care workers. Classes are too big for the child care workers to handle and there is a lack of funds available.
- 1178 I would like to see their regulations and the qualifications of the centre and the staff.
- 1076 It would be good to have better programming for each individual age group.
- 1187 Make sure all child care workers have their proper levels when working in a day care facility.
- 1044 My child often gets hurt by other kids. There are not enough staff for activities like potty training.
- 1356 My concern is that they have no camps for 8-12 years age group. They need to have a structure to accommodate my children. They have no activities for their r age groups. I worry because my children don't like to go and I can't leave them alone at home.
- 1055 My son is highly active so I need to ask staff for additional help to keep an eye on him.
- 1025 Pay child care workers better to reduce turnaround.
- 1343 Separate the older kids from the younger children. I don't like it at all when the older kids play rough with the younger children.
- 1392 The cost is too much for the day care.
- 1254 The high level of unavailable services is of concern.
- 1145 The pay is not good enough for the workers. Some workers don't stay with their job very long.
- 1258 The ratio of care givers to children is too low and should be changed. One care giver for twelve children is too hard on everyone.
- 1243 The space at the day care is limited. They no longer have a common room for group activities. There is also a high turn around of staff and low levels of certification among child care workers which is probably links to low wages.
- 1414 There is not enough inspectors.
- 1111 There isn't enough information about staff, and the day care provided.
- 1127 There needs to be more checks for day homes and day cares. To maintain a good reputation and to stay clean. Day cares should have to close for half of a day to clean the facility well when there has been an outbreak of something like lice.
- 1002 There should be smaller day cares with more of a home focus to manage the kids better.

- 1204 They had mould in the walls at the Church of the Nazarene Day Care.
- 1348 They should have daily reports and tell me what my son eats.
- 1038 They should look at fair wages for child care employees and set some minimum standards for workers working in that field.
- 1419 To make sure that regulations over the day cares are being met.
- 1346 We don't pay the workers enough. I like the idea of a National Child Care system.
- 1230 When I pick up my son the older school age children are playing rough with the younger kids. This should not be going on there.
- 1262 Workers of the day homes don't get paid enough to stay in that line of work. There are no benefits and when you go for a course it is taken off your paycheque. It should be paid for. Most people can't afford to lose that amount off your paycheque.

Q10.12 reasons provided for selecting this as most important?

1. Increase the number of licensed child care spaces in my community.

- 1 FDHO 1153 A lot of day cares are full.
- 1 FDHO 1108 Because there needs to be more licensed child care so parents can receive the subsidy.
- 1 FDHO 1113 I am limited to day cares who will take a child under 18 months. I live in Riverdale and I have to go to Lobird for care. I use public transportation to get around.
- 1 FDHO 1190 I am looking for another child care place because this one is closing. It is hard to find another place because they don't want part-time kids.
- 1 FDHO 1460 I know so many people that are looking for day care space and placed on a waiting list.
- 1 FDHO 1420 I think it's too crowded with children.
- 1 FDHO 1449 I was working in Mayo and there was no day care there. It was costing me \$200 a week for a babysitter, when I was getting \$500 from my job.
- 1 FDHO 1106 It is hard to find a place that will accommodate my work schedule.
- 1 FDHO 1131 So people that have to work have some good resources in the community.
- 1 FDHO 1201 There are not enough day care centres in Whitehorse.
- 1 FDHO 1019 There are not enough day homes. I have to drive from Porter Creek to Riverdale. There isn't many day care centres that care for children under 18-months-old.
- 1 FDHO 1289 There are not too many day cares or day homes who have space available.
- 1 FNDC 1315 Because in Haines Junction there's no spaces available.
- 1 FNDC 1242 Because this day care is really small and if you don't get in you won't get it.
- 1 FPDC 1109 Because I had my son on a waiting list for many months.
- 1 FPDC 1174 Because I live in Porter Creek and I can't find a day care available close to my home. All the day cares are full all the time.
- 1 FPDC 1022 Because it is really hard to find child care spaces in Whitehorse.
- 1 FPDC 1334 It's really hard to find space in day cares. You end up being on waiting lists for months sometimes.
- 1 FPDC 1389 More options for day homes would be good.
- 1 FPDC 1319 There's not enough spaces.

- 1 NPDC 1079 Because I have a younger child who I am trying to get into day care but I cannot find a space available.
- 1 NPDC 1221 I am finding it difficult because of my shift work. I would like to see a 24-hour day care for working parents with shift work.
- 1 NPDC 1306 I think there should be more day cares in Whitehorse. I think there is enough day homes.
- 1 NPDC 1284 It's hard to find a day care. It took me 2 months to find one. There wasn't enough space in the day cares.
- 1 NPDC 1273 So there is more availability for everyone.

2. Increase the quality of the programs offered by licensed child care services.

- 2 FDHO 1280 A quality program. The first day home I went to this year the provider was overworked and stressed. The second place didn't give my asthmatic child her medicine and had to be taken away by ambulance. It seems they are not being properly trained and they are not following proper procedures.
- 2 FDHO 1033 Because children need programs to work with.
- 2 FDHO 1257 Because good programs give the child a chance to learn before they go to school
- $2\ \mbox{FDHO}$ 1144 Because my daughter's day care doesn't have any programs offered that I know about.
- 2 FDHO 1436 Children need good programs.
- 2 FDHO 1077 Children should be raised by parents, but society forces us to go and work. So the more educational and nurturing programs we have for the children the better.
- 2 FDHO 1175 Other day cares don't offer enough activities, learning techniques, and attention to the kids. I think this should improve because it's very important to our children.
- 2 FDHO 1125 So that everyone gets good quality care.
- $2 \; \text{FNDC} \; 1234 \; \text{Because good programs give kids what they need and help working mothers.}$
- 2 FNDC 1101 Good programs, keep the children safe and happy.
- $2\ \text{FNDC}\ 1042\ \text{If kids}$ are given good programs early on it makes it easier for them when they enter school.
- 2 FNDC 1365 We need our children to have quality programs with education. They are in the care at a very developmental stage in their life.
- 2 FPDC 1149 Because I want good quality programs for my child while in day care.
- 2 FPDC 1029 Because busy kids do not get in trouble.
- 2 FPDC 1135 Because it encompasses all of the others.
- 2 FPDC 1015 Better quality programs can catch any problems in children early on so as preventative measures are not needed later on (which can be costly).

- 2 FPDC 1209 Children are getting older and they need to learn as they are growing. Older children should have programs for their age groups.
- 2 FPDC 1067 For me, it helps out the kids a lot later in life to have had a good head start before starting school.
- 2 FPDC 1053 I think that educating our children is very important. Programs that contribute to a child's brain development are very important.
- 2 FPDC 1124 These child care workers are helping me raise my child.
- 2 NPDC 1171 Because every child is unique and need specific things to help them; programs should be tailored accordingly.
- $2\ \text{NPDC}\ 1150\ \text{Because}$ good programs offered by good instructors is very important for the younger children.
- 2 NPDC 1049 Because it is for the development of the kids. The more you offer them the better.
- 2 NPDC 1170 Because it's important to train and take good care of the children while they are young. Offering programs will teach these children a lot.
- 2 NPDC 1371 I don't think they have enough programs offered.
- 2 NPDC 1343 Offer more programs instead of always playing
- 2 NPDC 1027 The programs offered are a little limited. My son just seems to be doing colouring in and nothing else.
- 2 NPDC 1230 This day care has no daily routine such as reading, art or learning. It seems like they play all day.
- 2 NPDC 1002 What we do with the kids is most important.

3. Increase funding for children with special needs.

- 3 FDHO 1426 Because special needs kids need extra one-on-one time.
- 3 FDHO 1380 I have a daughter who just moved up here who is special needs.
- 3 FDHO 1307 I have a friend who has a child with special needs and it was hard for her to find a qualified provider. Increasing funding will be of help to these kids.
- 3 FDHO 1183 I have a special needs child.
- 3 FDHO 1036 I think special needs children do not get recognized enough. They need a lot of equipment.
- 3 FDHO 1342 My niece in-law has special needs.
- 3 FDHO 1330 These kids need all the help they can get.
- 3 FNDC 1107 Because I have a child with special needs, to be able to have as much support in the help or developing the child the better.
- 3 FNDC 1084 Because a lot of kids have disabilities.

- 3 FNDC 1259 Because there are lots of special needs children in our community
- 3 FNDC 1117 I see a lot of children with special needs and day cares can't always give proper support.
- 3 FPDC 1332 Because it is the field of work I'm in and I have a lot of special needs clients
- 3 FPDC 1082 I have a child with a special needs; more funding help is always good.
- 3 FPDC 1024 I have taken care of special needs children and have found that not all of their needs are met.
- 3 FPDC 1357 It is hard with special needs children.
- 3 FPDC 1216 My daughter needs more help.
- 3 FPDC 1314 Not enough funding for children with special needs.
- $3\ \text{FPDC}\ 1056\ \text{There}$ are so many special needs children and not enough funding for them
- 3 FPDC 1176 They need the same attention as other children.
- 3 FPDC 1383 We don't have enough qualified people who can properly take care of children with special needs.
- 3 NPDC 1451 It is challenging to deal with special needs children.
- 3 NPDC 1161 It's fair to these kids to receive the special care.
- 3 NPDC 1465 It's very expensive.
- 3 NPDC 1103 More funding to assist in the training of workers who deal with children with special needs in communities. They are hard to find.
- 3 NPDC 1372 Special needs children need more support than say regular children, and workers need the proper education to care for them.
- 3 NPDC 1363 The children require more help with learning and care.
- 3 NPDC 1211 There are babies that have special needs and they need the attention.

4. Decrease the cost of licensed child care services for low income families.

- 4 FDHO 1335 Because I am a low income earner
- 4 FDHO 1464 Because I am in a low income family.
- $4\ \text{FDHO}\ 1089$ Because more people could pay form their own pockets, rather than taking from the taxpayers.
- 4 FDHO 1441 Being a low income mother, my budget is tight.
- 4 FDHO 1156 For low income families, they shouldn't have to pay so much.
- 4 FDHO 1333 I am a single parent

- 4 FDHO 1159 I find that the subsidy doesn't take into consideration the gross income of the low income families. Some families can't afford day care cost because of other bills they have to pay.
- 4 FDHO 1249 I would have kept my son in the day home longer if the cost was lowered
- 4 FDHO 1362 I'm a single mother who doesn't receive child support.
- 4 FDHO 1457 It costs more to send children to day care than for them to stay on welfare. I know what it feels like, I've been there.
- 4 FDHO 1456 It helps out a lot because I am a single parent.
- 4 FDHO 1074 It is less stress on parents not having to worry about money.
- 4 FDHO 1410 It would just make it easier on tight budgets.
- 4 FDHO 1428 So as low income earners are able to go to work.
- 4 FDHO 1302 The cost of day care is too high because I am only one person earning not much money and I also have other costs as well, like food and rent.
- 4 FDHO 1070 There are a lot of single mothers out there with one to three kids who need a break, and with only one income it makes it hard to pay for everything.
- $4\ \text{FDHO}\ 1374\ \text{We}$ need more money for other activities, like dancing, or sports. All the money goes to day care now.
- 4 FNDC 1270 Because it is hard for low income families to afford child care on top of all the other bills they have to pay.
- 4 FNDC 1256 Because low income earners cannot pay the high cost of child care.
- 4 FNDC 1198 I am a single mother and I only make a moderate income.
- 4 FNDC 1003 I don't earn all that much money.
- 4 FNDC 1208 I have to pay too much as a single parent
- 4 FNDC 1168 I think the cost is too much.
- 4 FNDC 1265 This is important because the cost of living goes up.
- $4\ \mbox{FPDC}$ 1228 At one time I was paying more for child care than my mortgage payments
- 4 FPDC 1398 Because of my budget I was paying quite a bit. When I was able to receive a subsidy, it helped with payments.
- 4 FPDC 1120 I am a low income earner.
- 4 FPDC 1219 I am a low-income single parent too.
- 4 FPDC 1391 I can't get subsidy because I'm not working or going to school, so I have to pay the whole amount myself and I can't work because of my health issues.
- 4 FPDC 1155 I do have low income and it's hard to afford.

- $4\ \mbox{FPDC}\ 1071\ \mbox{I}$ have a low income and I only get support for one child for child care.
- 4 FPDC 1073 If I was not receiving a subsidy and had to pay for the day care cost myself totally out of my wages I would not be able to afford it.
- 4 FPDC 1281 It would just make it easier on the budget.
- 4 FPDC 1130 It's difficult to pay the cost of day care when you have a low income.
- 4 FPDC 1278 Kids from low income families need good care.
- 4 FPDC 1134 Low income family can't afford to pay extra money for child care.
- 4 FPDC 1250 Most child care is around \$650 and subsidy only covers around \$500, which is hard if you are a low income earner.
- 4 FPDC 1200 Personal income reasons are important. The amount the single parents pay is too high and it should be decreased. The government should give the day cares the money so parents don't have to worry about applying monthly.
- 4 FPDC 1325 Sometimes I can't even make the extra seventy-five dollars I have to pay.
- 4 FPDC 1288 The more you make, money is taken off for subsidy. By getting a raise at work, you get put in a different price bracket for subsidy. And then I have to make up the difference for care.
- 4 FPDC 1218 The situation is very close to our income.
- 4 FPDC 1320 There's a lot of families out there that can't go to work because of the high cost of day care and low minimum wage.
- 4 FPDC 1011 When the centres close for PD days I have to subsidize it.
- $4\ \text{FPDC}\ 1091\ \text{When you don't have a large income it is sometimes hard to pay for everything.}$
- 4 FPDC 1169 Without government funding you couldn't afford day care. There are other things to pay as well, such as mortgage, food. We need affordable day care because we need to work in order to have any quality of life.
- $4\ \mathrm{NPDC}\ 1031\ \mathrm{Because}\ \mathrm{I}\ \mathrm{have}\ \mathrm{friends}\ \mathrm{that}\ \mathrm{say}\ \mathrm{most}\ \mathrm{of}\ \mathrm{their}\ \mathrm{cheques}\ \mathrm{go}\ \mathrm{to}\ \mathrm{child}\ \mathrm{care}.$
- 4 NPDC 1405 Because I'm a single mother and I'm not employed or in school right now.
- 4 NPDC 1179 Because while paying for day care some people are also paying for other extra activities as well.
- 4 NPDC 1266 Because without further subsidizing child care it is hard for low income earners to get ahead.
- 4 NPDC 1229 I am on my own now and it makes it tough.
- 4 NPDC 1127 I'm low income and I can barely afford food. If my day care cost goes up I simply can't afford it.

- 4 NPDC 1021 It seems like the most reasonable option.
- 4 NPDC 1397 It would make it easier on the budget.
- 4 NPDC 1202 Low income families shouldn't have to scrape by.
- 4 NPDC 1111 Most families have more than one child and the cost of living is so high.
- 4 NPDC 1453 People struggle with their other finances. It's hard when I am a single parent.
- 4 NPDC 1192 The government considers me as making too much money and I'm a single parent just getting by.

5. Assist in the recruitment, training, and retention of child care workers.

- 5 FDHO 1252 Child care is a profession that is almost as structured as teaching. It has a lot of demands and a lot of stress.
- 5 FDHO 1253 Enforcing safety regulations are most important.
- 5 FDHO 1304 I feel that the staff with First Aid and proper training are safe.
- 5 FDHO 1373 I think the more childcare providers we have the more our children will get out of it.
- 5 FDHO 1318 Seems to be a lack of support for care providers.
- 5 FDHO 1129 We need experienced workers.
- 5 FNDC 1439 Because a lot of child care workers don't have adequate skills.
- 5 FNDC 1052 Because if they are not adequately trained and paid they don't have much dedication to the job and therefore less energy to deal with the children.
- $5\ \text{FNDC}\ 1034\ \text{Because}$ it ties in with all the others. Better wages means happier staff, better service and higher retention of staff
- 5 FNDC 1323 Fully qualified people, provide a safer environment for our children.
- 5 FNDC 1462 The facility that my daughter was at, they changed child care workers 3 times in 1 year. They should be more qualified child care workers.
- 5 FNDC 1409 To get the best of the group more education is better.
- 5 FNDC 1297 We want people with qualifications taking care of our children.
- 5 FNDC 1411 Workers should be trained to their fullest capacity. They should perhaps look elsewhere to find qualified persons.
- 5 FPDC 1086 Better qualified care workers will be able to provide better service to our children, so that parents can feel more comfortable as well.
- $5\ \text{FPDC}\ 1146\ \text{I}$ think that there are people out there that could work in child care, but the wages are low. I think the government should help subsidize the wages.

- 5 FPDC 1137 It's too much to afford when on a low income.
- 5 FPDC 1290 The more qualified workers the better.
- 5 FPDC 1205 We need more child care workers and facilities.
- 5 NPDC 1139 At the day care they had different workers all the time. I think the children didn't get a chance to get used to a certain worker.
- 5 NPDC 1044 Because there are a few child care workers that are not fully trained and don't watch the children that well.
- $5\ \text{NPDC}\ 1046\ \text{Because}$ there is a high turnover in this industry and the children become attached to the workers.
- 5 NPDC 1356 Child care workers should have proper levels.
- 5 NPDC 1408 I don't think some workers are qualified.
- 5 NPDC 1172 I think the children deserve to bond with their child care workers. Some of the workers leave the day care after getting to know the children.
- 5 NPDC 1345 If people are interested in child care as a profession they should be assisted through school.
- 5 NPDC 1093 If we don't have properly qualified people it's not going to matter how much funding is in child care. Better qualified people, the better off our children are.
- $5\ \mbox{NPDC}$ 1369 It is important knowing that my child is in good hands and in good care.
- $5\ \text{NPDC}\ 1025\ \text{Our}$ children are being raised by child care workers therefore they need to be educated.
- 5 NPDC 1132 Some of the workers don't have their First Aid and the Early Childhood education.
- 5 NPDC 1352 There is not enough incentive to keep the workers at one location

6. Support the use of community schools by child care programs or after school programs.

- 6 FDHO 1240 If the school had after school programs until 5:00 PM that would be great. I pick my son up from school and bring him to the day home. He is only 5-years-old. I would not let him walk to day care.
- 6 FDHO 1294 It would give the children more options than say, just what the day cares can offer.
- 6 FDHO 1186 My child will require after school care
- 6 FNDC 1377 Because it is hard for a lot of working parents to be able to pick their children up after school and take them to the day care. It would be easier if they just stayed at the school.
- 6 FPDC 1321 I think it's important for kids to do something after school rather than going home or when their parents are at work.

- 6 FPDC 1224 I think the majority of the schools should have programs for after school children. It's difficult for parents to leave work, pickup their children and bring them to day care.
- 6 FPDC 1454 It would be great to have an after-school in the schools. Having qualified people run these programs would be great.
- 6 FPDC 1182 It would decrease the load on day cares. It would be better for the kids if everything could be at their school and they would not have to go to a day care. Also, people would pay less if schools were used.
- 6 FPDC 1427 My daughter is close to school age, and having more of a positive and educational place to go after school would be beneficial for our children.
- $6\ \text{FPDC}\ 1005\ \text{My}\ \text{son}\ \text{goes}\ \text{to}\ \text{Hidden Valley School},\ \text{which}\ \text{is out of town,}\ \text{and}\ \text{there}\ \text{is no}\ \text{child}\ \text{care}\ \text{after school}\ \text{there}\ \text{so}\ \text{he}\ \text{has}\ \text{to}\ \text{be}\ \text{picked}\ \text{up}\ \text{and}\ \text{taken}\ \text{to}\ \text{child}\ \text{care}.$
- 6 FPDC 1434 Our society does not have enough positive things for our children to do after schools. They are surrounded by negative things. If there were more after school programs, my daughter could go there and not take up space at the day care, where someone else could put their child who needed to.
- 6 FPDC 1341 The community needs more after school care.
- 6 NPDC 1443 Because children need a place to go after school.
- 6 NPDC 1231 Because it is important for kids to do activities after school.
- 6 NPDC 1348 Have more programs so children can have fun and get along.
- $6\ \text{NPDC}\ 1059\ \text{If}$ there was more after school care less children would need to be in day care.
- 6 NPDC 1459 It helps me with my school schedule.

7. Improve the enforcement of existing regulations governing licensed child care.

- 7 FDHO 1054 Because in a previous day care I have seen neglect and staff not being properly trained.
- 7 FDHO 1248 Day care centres need to be more heavily monitored because parents don't know what is going on.
- 7 FDHO 1222 I would like to see the regulations at my day home.
- 7 FDHO 1119 Knowing that our children are safe makes parents feel better.
- 7 FNDC 1098 Knowing that where your child is going for the day is a safe environment.
- 7 FPDC 1085 By what I've heard and seen. To keep an eye on violence and bad language.
- $7\ \text{FPDC}\ 1367\ \text{For}$ the safety in general of our children. They need a secure safe environment.
- 7 FPDC 1432 I feel they are not regulated enough from centre to centre.

- 7 FPDC 1066 If the Child Care Service Unit had more funding they could check to see if the children had a clean and safe place to be in.
- 7 FPDC 1282 Knowing that they are safe.
- 7 FPDC 1393 Some of the current rules and regulations need to change.
- 7 FPDC 1061 To make sure that the children are safe.
- 7 NPDC 1213 All the child care funding comes from the regulations.
- 7 NPDC 1178 I didn't know if the child care was actually following the regulations and if they were being monitored.
- 7 NPDC 1419 I had my children in a day care that was not organized, the staff were not very fit for child care. The environment was just not good.
- 7 NPDC 1375 Kids spend so much time away from parents, it is like a second home. They need to be in a safe and secure place.
- 7 NPDC 1188 People will slack off if there isn't proper governing.
- 7 NPDC 1237 They should look into the background of all child care workers.

8. Increase the wages of child care providers.

- 8 FDHO 1194 Because if they are not paid enough, turnover is too high.
- 8 FDHO 1030 Because it connects with all other actions. There is high turnover and it is hard to retain staff as the wages are too low.
- 8 FDHO 1060 Because it is a lot of work caring for 5 to 6 children a day.
- 8 FDHO 1217 Because it is hard work.
- 8 FDHO 1050 Because they are paid next to nothing.
- $8\ \mbox{FDHO}\ 1322\ \mbox{I'm}$ not sure how much they make, but they should be getting good pay for the work they do.
- $8\ \mbox{FDHO}\ 1195$ If the child care providers were paid more we would have more of them going to school for that.
- $8\ \mbox{FDHO}\ 1384\ \mbox{If the wages were increased, day cares would be able to keep qualified staff longer. There is too much of a staff turnover.$
- $8\ \mbox{FDHO}\ 1339$ If they are paid better they will take care of my child better and stay longer at the daycares.
- $8\ \mbox{FDHO}\ 1329$ It is very tough for day care centres to keep workers at the amount they're getting paid.
- 8 FDHO 1425 It would decrease staff turnover.
- 8 FNDC 1177 Because I think they do a lot of work.
- 8 FNDC 1238 Because child care workers are currently on a low income.
- $8\ \mbox{FNDC}\ 1133\ \mbox{Because}$ they work hard from $8\ \mbox{AM}$ to $6\ \mbox{PM}$ and are busy every day. They deserve more.

- 8 FNDC 1096 Child care workers should have certain levels of education. Child care should be equally as important as teaching and should come under "education".
- 8 FNDC 1382 I know they start workers at minimum wage which is too low.
- 8 FNDC 1435 If you pay more, you will draw in good people who want to stay. If they stay longer they get to know each child. Once they know these children, friendships and bonds can form with the children and their families. They know my children and how to be with them and what to expect from them. They know how to deal with my children and then we can work together. We are losing too many good people.
- $8 \ \text{FNDC} \ 1279 \ \text{Low}$ wages are probably the reason why it is hard to keep people in the profession.
- 8 FNDC 1376 So as staff would be more committed to upgrading their education and staff turnover would decrease.
- 8 FNDC 1301 The pay is low for day care workers.
- 8 FNDC 1412 The workers work hard and should be paid accordingly.
- 8 FPDC 1438 Because child care workers work harder than any other profession.
- 8 FPDC 1116 Because people are more motivated to go and do a good job when they are paid well.
- 8 FPDC 1065 Child care providers are not getting enough. They are paid a little amount. They put out more than they bring in.
- $8\ \mbox{FPDC}\ 1331\ \mbox{I}$ am making \$11.00/hr at level 1. I was taking care of $8\ \mbox{4-year-olds}$ by myself. It is stressful and a lot of responsibility for a pathetic low wage.
- 8 FPDC 1166 I don't think they get paid enough for the amount of work they do.
- 8 FPDC 1152 I don't think they get paid enough for what they do.
- 8 FPDC 1276 I think that child care workers should be paid more because they are developing the livelihood of our children, caring for them.
- 8 FPDC 1122 I think the child care workers aren't getting paid enough.
- 8 FPDC 1401 I think they should be paid more.
- $8\ \mbox{FPDC}\ 1001\ \mbox{It}$ is important so as good workers are retained and turnover is lowered.
- 8 FPDC 1012 It would stop the high turnover.
- 8 FPDC 1291 Paying workers more will provide parents with better service.
- $8\ \mbox{FPDC}\ 1035\ \mbox{So}$ as properly trained staff stick around longer, which is very important for the children.

- 8 FPDC 1225 The child care workers are with children all day. They have to feed, change and play with kids all day.
- 8 FPDC 1233 The do a very important job, raising our children at a very critical age. But if the child care workers can't make ends meet they can't stay in the field of work.
- 8 FPDC 1390 The pay that they receive doesn't reflect how much work they do and how important their job is.
- 8 FPDC 1092 The workers are underpaid. I think you get what you pay for and the quality then is a concern. Low wages mean high staff turnover, which is not good for the children or the day care.
- 8 FPDC 1239 They are very underpaid and they look after our children all day.
- 8 FPDC 1296 They are very underpaid for the work they do.
- 8 NPDC 1254 Because I would be willing to pay more to ensure that my child gets the best quality staff he can.
- 8 NPDC 1245 Because child care workers are doing an important service and get paid very little. If they were paid better they may stay longer.
- 8 NPDC 1043 Because high staff turnover is distressing to the children.
- 8 NPDC 1243 Because if there is high staff turn around due to low wages it is hard to build good programs and develop good relationships with the children.
- 8 NPDC 1414 Because if wages are raised the workers will stick to their job.
- 8 NPDC 1269 Because their job is very hard.
- $8\ \mbox{NPDC}$ 1298 For the amount of work that they do they should be paid much higher. They are raising other people's children.
- 8 NPDC 1076 Happy workers create a happy environment.
- 8 NPDC 1353 I am a child care provider and it would be nice to get a generous wage for the amount of work I do.
- 8 NPDC 1309 I think it's great for them to stay at their job.
- 8 NPDC 1147 I think more money should be put into wages for staff.
- 8 NPDC 1429 I was a child care worker for 20 years, they need to be paid more.
- 8 NPDC 1016 If the staff at child care centres are happy then the kids are happy.
- 8 NPDC 1396 If the wages were increased it would also solve the other action I rated five which has to do with the retention of child care workers. Child care workers would be willing to stick around if they were paid more. Our day care is having a heck of a time keeping workers and part of this is because of wages they are paid. A lot of these workers come from Montreal where they are paid way more. They come here only to leave to go back to Montreal. We are losing a lot of qualified day care workers. We just lost another woman who is excellent.
- 8 NPDC 1392 If they got paid more they would stay with their job.

- 8 NPDC 1446 If they required more training and skills and therefore got paid more you would end up with more people in the profession that actually love this kind of work.
- 8 NPDC 1346 It is hard to keep the workers consistent. There is very high turnover.
- 8 NPDC 1226 It is the hardest job to do because they are in care for 10 hours. I think about the staff's well-being.
- 8 NPDC 1181 It will keep the child care workers at the job longer too.
- 8 NPDC 1118 It would increase the number of people wanting to go into child care. It would also improve the environment the children are in.
- $8\ \mathrm{NPDC}\ 1204\ \mathrm{More}\ \mathrm{wages}\ \mathrm{for}\ \mathrm{staff}\ \mathrm{means}\ \mathrm{less}\ \mathrm{fluctuations}\ \mathrm{in}\ \mathrm{staff}\ \mathrm{and}\ \mathrm{more}\ \mathrm{stability}\ \mathrm{for}\ \mathrm{the}\ \mathrm{children}.$
- $8\ \text{NPDC}\ 1004\ \text{The work child}$ care providers do is the most important kind of work, yet they are paid the least.
- 8 NPDC 1258 The workers are working so hard but don't get paid well.
- $8\ \mathrm{NPDC}\ 1105\ \mathrm{These}\ \mathrm{child}\ \mathrm{care}\ \mathrm{workers}\ \mathrm{are}\ \mathrm{doing}\ \mathrm{such}\ \mathrm{an}\ \mathrm{important}\ \mathrm{job}\ \mathrm{they}\ \mathrm{should}\ \mathrm{be}\ \mathrm{paid}\ \mathrm{better}.$
- 8 NPDC 1212 They are the lowest paid workers and their job is the busiest.
- 8 NPDC 1145 They don't like the pay so they leave the job. Too many new workers very few months.
- 8 NPDC 1300 They work hard and should be paid accordingly.
- $8\ \mathrm{NPDC}\ 1379\ \mathrm{Workers}\ \mathrm{need}$ to be given more incentive to want to stay and be in that field of work.

Q12 What can CCS unit do to improve service to you?

Family Day Home Clients

FDHO 1159 Be more courteous and understanding when it comes to medical issues.

FDHO 1342 Be nicer to the clients.

FDHO 1257 Because I am a single grandmother they should give me more subsidy.

FDHO 1335 Don't cut their funding

FDHO 1420 Educate the staff more.

FDHO 1144 Explain the process better. Make the service understandable.

FDHO 1074 Give out more funding for low income families.

FDHO 1186 Hire some staff that can do the job. It is pathetic and I have never seen a more pathetic organization. I don't like the re-applying. They do not take the time to do a good job. They are quick to cut you off, but it takes one month to approve again. Hire more staff that are more understanding.

FDHO 1428 I often get "no answer" or voicemail when I call them. Therefore there should be more staff to answer general questions.

FDHO 1304 I think that the unit should consider other bills (expenses) that I have rather than looking at my income only.

FDHO 1329 Increase the amount of subsidy. It's very tough to make ends meet.

FDHO 1318 List the day cares that have vacancies.

FDHO 1195 Look at individual cases and not only specific subsidy forms. Have more child care in the area of Northlands.

FDHO 1131 Make a program that all Yukoners understand.

FDHO 1019 Make it easier to obtain the subsidy.

FDHO 1456 Make it so the clients have easier access to speak to the supervisors. It takes way too long to speak to the supervisor, sometimes days. I don't want to deal with the receptionist. When parents have complaints or issues they should be able to speak to someone immediately.

FDHO 1030 Make the guidelines on who is eligible for subsidy clearer. Be more knowledgeable and considerate of the financial needs of child care providers when advising parents on the subsidy application. Be clearer about deadlines for subsidy applications and provide support beyond child care legislation for child care providers.

FDHO 1108 Move out of Quartz Road. There is no safe walkway for parents with young children to walk on. It is just not convenient.

FDHO 1194 Nothing

FDHO 1307 Nothing right now.

FDHO 1362 Nothing right now.

FDHO 1175 Nothing right now. Keep it the same.

FDHO 1330 Nothing, I'm satisfied.

FDHO 1113 Nothing.

FDHO 1183 Nothing.

FDHO 1410 Nothing.

FDHO 1023 Nothing.

FDHO 1033 Nothing; they are doing a good job.

FDHO 1249 Parents should be informed better about changes to the parental contribution each month.

FDHO 1190 Provide more day care for after school kids.

FDHO 1240 Provide more funding.

FDHO 1244 Raise the amount of subsidy given.

FDHO 1333 Raise the amount of the subsidy

FDHO 1206 Take into account my gross income and my other expenses such as bills, rent, food and clothing as a single parent when calculating the subsidy amount I qualify for.

FDHO 1460 There are too many people waiting on a list for child care. There should be more day cares, day homes and child care workers too.

FDHO 1374 There is a lack of training or formal education. Have more qualified workers working there. It would show a more professional atmosphere.

FDHO 1436 There should be better cooperation with the maintenance enforcement unit. There is a lack of communication here.

FDHO 1280 They could have a community meeting. They need to consult with parents and workers more often.

FDHO 1156 They could have someone behind the desk to answer phones and questions at all times. They could be more understanding to single parents.

FDHO 1222 They didn't tell me that they took my payments back from the day care. I had to give them my pay stubs from November 2005. The lady at the Child Care Services Unit was rude and hung-up on me. She accused me of not bringing in my stubs and now I can't afford to pay \$500 for one month of child care.

FDHO 1322 They need someone there to meet my needs. I tried to call the unit a number of times and got nowhere. I then found out that they had one worker working that day.

FDHO 1054 They need to be more accessible. It is hard to get a hold of them to see if things have been approved. They need to make it easier to find out the criteria for the subsidy, for example the income cut-offs. They should increase the subsidy limit.

FDHO 1060 They need to look at the other bills that parents have (for example, rent or mortgage payments) and not just their wages when deciding on the subsidy.

FDHO 1036 They should take more information into consideration when figuring out subsidies. There should be a council of 2 to 3 people that looks at every situation on a case-by-case basis.

FDHO 1384 Things aren't cross referenced. The staff are not very organized. Things need to be more organized.

FDHO 1164 To help more single parents that are trying to work. Increase funding for single parents that are working full time.

FNDC 1376 Better support for the day cares. More education and training courses for day care workers and to raise the current level of pay.

First Nation Day Care Centre Clients

FNDC 1052 Come and visit me sometimes and give me some help because I am a grandmother.

FNDC 1435 Continue providing the service.

FNDC 1270 Decrease the cost of the child care

FNDC 1409 Extended day care hours for those that have to work, particularly for seasonal workers.

FNDC 1223 Have more qualified workers who know what they are doing. They always seem to mysteriously lose my subsidy forms, 3 times.

FNDC 1042 I know that our day care director has had some communication problems with the unit. They should open the lines of communication.

FNDC 1279 It is fine the way it is.

FNDC 1098 It should be known that you can phone the Child Care Unit to voice your concerns about day cares. Most parents don't know that you can phone.

FNDC 1315 It would be great if they can approve funding for babysitters.

FNDC 1107 Make subsidy process easier, streamline the administrative process.

FNDC 1133 More funding.

FNDC 1412 Nothing

FNDC 1259 Nothing, I have no problems

FNDC 1377 Nothing, I'm pretty happy with the service.

FNDC 1198 Nothing.

FNDC 1265 Nothing; it's good.

FNDC 1365 Pay more attention to the files of the applicants. Every time I reapply I feel Like I have to remind them of who I am.

FNDC 1034 There needs to be more subsidy. The Yukon Government should give more money to Health and Social Services. They are also understaffed so this issue should be addressed also.

FNDC 1197 They could be open longer hours, for example either earlier in the morning or later in the afternoon. If you are working it's hard to see anyone there without taking time off work.

FNDC 1096 They should base the subsidy on the number of dependant children in a family not solely on the number of children in care.

FNDC 1439 They should provide more training for child care workers and more services for working mothers.

For Profit Day Care Clients

FPDC 1086 Be a little bit more flexible when it comes to getting your application in on time.

FPDC 1116 Be happy when people go in there.

FPDC 1228 Be more accountable and open when it comes to calculations. Calculate proper. I would like to see chart of income verses subsidy.

FPDC 1432 Be more careful where they send letters because they sent my exsister-in-law's subsidy forms to my address.

FPDC 1390 Be more human orientated rather than business orientated. Make the process for applying for subsidy easier.

FPDC 1135 Be more open regarding complaints about child care workers. Be more flexible with holding spots open for children whose parents can care for them for brief periods.

FPDC 1200 Change the re-application form, it is a hassle applying monthly. I have 2 children, only one is in child care. I have to sign one month prior and I am off work because of surgery.

FPDC 1225 Extend the child care centres to a later hour.

FPDC 1056 Getting subsidy more quickly and promptly. Not having eight people deal with one file.

FPDC 1424 Have a more thorough assessment of application and not have to apply every month. Sometimes my husband is working and sometimes he is not. If he has a contract one month we don't get funding, if he doesn't, we do. They need to put all considerations into fact when processing applications.

FPDC 1205 Have surprise visits to the day home, day cares. I saw some very dirty day care facilities.

FPDC 1219 Have the rates keep up with the cost of inflation.

FPDC 1123 Help out when my income changes. My marital status has changed and they are cutting me off child care. We would have to pay \$1500.00/month out of our pockets. We can't afford it.

FPDC 1085 I did have to reapply every three months and every time I had to get a letter from Family Services when they already had ten letters. They should have approved for me for a year.

FPDC 1332 I have no complaints

FPDC 1319 I think the location of the unit is too far to go when applying for subsidy.

FPDC 1325 I think they are good.

FPDC 1401 I think they need more workers.

FPDC 1092 I'm a full time student but sometimes I need to work. When I'm looking for work they will only pay for part time care. When that happens I either have to drop the full time care which will give up that spot or pay for it myself.

FPDC 1437 Increase funding for single income families. They need to also look at the total debts of each family (including rent).

FPDC 1220 Increase subsidy amount. I can't afford day care and I had to quit my job. I was barely making it. They need to help us parents try to keep our jobs and not worry about child care subsidy. It is not a subsidy if they cut parents off child care.

FPDC 1331 Increase the child care worker's wages. Screen the people who work with children more. Have more unexpected visits to the child care centres.

FPDC 1296 Increase the subsidies for low income parents.

FPDC 1065 Increase wages for child care workers.

FPDC 1029 It would be nicer if the subsidy was available to more families.

FPDC 1276 Lay out clear details for applications to make it smoother and more understandable.

FPDC 1011 Look at a subsidy for PD days because they add up.

FPDC 1393 Look at the current rules and regulations when children go to kindergarten and no longer need full time child care positions.

FPDC 1061 Make it easier for low income families to use child care, not be limited to day cares, but other programs with educational things in it.

FPDC 1182 Not make me reapply every six months. They know I am on Welfare and have an injured back. It is hard for me to get paperwork in because it is hard to walk. Until the call comes from my social worker saying I am no longer needing subsidy - I don't think I should have to fill out the same paperwork. It would save them time as well.

FPDC 1233 Nothing

FPDC 1320 Nothing right now.

FPDC 1152 Nothing, I'm satisfied with their service.

FPDC 1022 Nothing, the service is fine.

FPDC 1334 Nothing.

FPDC 1067 Nothing.

FPDC 1218 Nothing.

FPDC 1427 Nothing.

FPDC 1239 Nothing.

FPDC 1053 Nothing. I am thankful for their service.

FPDC 1024 Nothing. Their service is pretty good.

FPDC 1174 Offer more funding; subsidy pays only so much and I had to pay the rest. I think it wasn't affordable.

FPDC 1130 Offer more help with subsidy. Make it easier to get subsidy.

FPDC 1066 Regularly visit the day cares to see if they are clean.

FPDC 1109 Speed the process up. Let the parents know information right away, don't wait for days.

FPDC 1288 Taking less off the subsidy whenever you go up in pay. A dollar or so raise does not make much of a difference. The more that is taken off, I have to pay that amount myself. It is almost not worth it, getting a raise.

FPDC 1073 The could offer a day care subsidy to parents even if they are not working. As a single parent you need to have a break from your children so that you can do things such as clean your house, re-energize yourself so you can provide better care and also so you can plan activities for your children. I work at the day care part time so that I can have my children in care and get the breaks and support I need.

FPDC 1151 The subsidy should lower the prices of day care cost.

FPDC 1278 Their service is pretty good.

FPDC 1012 There are a lot of problems being a casual worker. They require a lot of information (not just pay stubs) to get the subsidy going.

FPDC 1005 There isn't anything; they are currently really good.

FPDC 1314 There's no consistency in what they require in the forms for self-employed parents.

FPDC 1224 They are short staffed and they never do follow-up calls to parents. It is frustrating when they never update parents. If they had more staff, perhaps this would be done.

FPDC 1295 They need to be a little more personal. Have better contact with the people who go through the child care service unit. I had mailed something in one time and they never got it. They did not call to tell me or ask me about it. I had to call them and find out.

FPDC 1146 They need to change the self-employment form for people who are in the trades industry, make it more applicable. I think reapplying is a bit of a problem for some people.

FPDC 1015 They need to educate people more and increase their awareness of programs and services.

FPDC 1155 They should extend the time for parents that are trying to find a job.

FPDC 1026 They should make the time you have to reapply for subsidy longer than six months.

FPDC 1260 They should properly screen the workers. I want to know what kind of people were taking care of my sister.

FPDC 1124 Train and recruit more child care workers and up the wages for child care workers.

FPDC 1321 Train the staff better.

FPDC 1001 When applying for the subsidy, parents should not have to jump through so many hoops. Particularly when the parents are self-employed it becomes very difficult.

Non Profit Day Care Clients

NPDC 1258 A parent they are really good. The should look at the cap on the subsidy amount. Maybe it should go up.

NPDC 1243 Applying got the subsidy is a long process. It is unclear about who (the provider or the parent) do what.

NPDC 1145 At this point, nothing.

NPDC 1213 Don't cut the child care cost.

NPDC 1396 Easy, redefine what part-time and full-time work means. I can understand they don't want people to abuse the system, but I can only work two hours too many. My kids only go two days a week. I am penalized because of the extra two hours. I am losing one hundred and fifty dollars in subsidy a month. I certainly don't make that in two hours. It would make sense if my kids went full-time and I worked full-time. The amount of subsidy should be based on my wages and how much money I take home.

NPDC 1375 Faster processing time of subsidy application.

NPDC 1103 Give less paperwork. I am always behind on them.

NPDC 1178 Give me more information.

NPDC 1359 Have full-time staff; I seem to be dealing with a new person all the time.

NPDC 1459 Have more after school child care for working teen parents.

NPDC 1277 Have on the subsidy form that if you make a certain gross income you don't qualify. Otherwise you go through the process only to be denied.

NPDC 1371 Have transportation available to and from the day care.

NPDC 1044 Help get all child care workers fully trained.

NPDC 1414 Hire more inspectors. When applying for subsidy the process takes too long. They should speed up the process.

NPDC 1299 Hire more staff to go out into the day cares to check and make sure everything is as it should be.

NPDC 1009 I don't have any problems with their service.

NPDC 1345 Improve their clarity. I have noticed inconsistency when applying for the subsidy. The wording on documents needs more clarity. I often get different answers from different people.

NPDC 1105 Increase regulations for day cares to make sure that the staff are properly trained.

NPDC 1147 Increase subsidy rates.

NPDC 1429 Increase the subsidy, make availability for middle income families to have subsidy. When you have a mortgage it is tight on the monthly income.

NPDC 1309 It would be helpful for me to know how they determine the subsidy. How much subsidy would I get?

NPDC 1171 Lengthen the amount of time before you need to redo the paperwork to get the subsidy. Renewing it every six months is too much.

NPDC 1202 Let me get an estimate of how much I have to pay with my income for subsidy.

NPDC 1221 Make no mistakes and don't calculate maintenance money. A mistake was made and they did not tell me. They should be more clear.

NPDC 1076 More funding for child care, whether it be in wage increases or programs.

NPDC 1111 More inspections to the day cares on a regular basis, and more often.

NPDC 1463 No, it's pretty good.

NPDC 1419 Not really.

NPDC 1093 Nothing

NPDC 1031 Nothing really.

NPDC 1306 Nothing right now.

NPDC 1161 Nothing right now.

NPDC 1027 Nothing they do well in the dealings I've had with them.

NPDC 1316 Nothing, I am satisfied with the service.

NPDC 1038 Nothing.

NPDC 1230 Nothing.

NPDC 1211 Nothing.

NPDC 1397 Nothing.

NPDC 1369 Nothing.

NPDC 1025 Nothing.

NPDC 1348 Nothing.

NPDC 1059 Nothing.

NPDC 1043 Nothing.

NPDC 1353 Nothing.

NPDC 1346 Nothing.

NPDC 1452 Nothing.

NPDC 1179 Re-look at the prices of day care.

NPDC 1453 Send a letter to remind parents to re-apply.

NPDC 1356 Single parents should have full child care subsidy. I would like more programs for children from ages 6-year-old and up. There is no programs for these ages in Whitehorse.

NPDC 1002 Smile more and be more cheerful.

NPDC 1150 The overall management of the unit could be better staffed. It seems that the unit is understaffed.

NPDC 1226 The quality of staff needs to improve.

NPDC 1408 The staff should be more helpful in calling people back right away if they need information, not waiting for days.

NPDC 1245 There should be more follow-up when you apply. They send out letters with no explanation, they should provide more information.

NPDC 1465 There should be more time allowed to get your papers into the office.

NPDC 1016 They are pretty accommodating, but they could make it more accessible to people on low incomes.

NPDC 1392 They could be more consistent with their monthly payments to the day cares.

NPDC 1254 They need more coverage for the parents in day care, particularly in the summer months.

NPDC 1443 They need more staff available to answer questions.

NPDC 1192 They need more staff.

NPDC 1018 They need more staff. Even though this is a small community we have a lot of kids.

NPDC 1046 They need to look at what they classify as high income families and perhaps raise the limits for parents with two children.

NPDC 1127 They need to make it easier. They should have one form, that's it. Since I've been on Social Assistance, it's running around, phoning, and jumping through hoops. They need to make it easier, especially for low income families.

What if we have no phone or I get a job and need the money immediately for day care?

NPDC 1004 They need to monitor day care centres better and follow through on complaints.

NPDC 1446 They should adapt their language to someone who doesn't know the system well.

NPDC 1132 To have more staff available at all times so someone would keep track of information at all times.

NPDC 1229 Try to be empathetic towards clients.

NPDC 1273 When they notify you of a change they should leave it for about a month so you can adjust to it. They seem to change things too quickly.

NPDC 1262 Widen the range for applying for funding so that even parents who both work can have a decent amount of subsidy. Even if both parents are working, minimum wage is so low. They don't take into consideration everything else that you pay for as well, like rent, food, and transportation.

Q13.1 Yes, description of problems experienced with the Child Care Services unit?

Family Day Home Clients

FDHO 1156 A staff member has called me and accused me of lying about how many children I have. They (staff) have no right to accuse me of anything.

FDHO 1374 Being looked at as not being able to give the care and love that a mother could give. It seems that I am discriminated against for being a single father.

FDHO 1030 Being told that there was no rush in getting in a subsidy application when it actually delays my child care provider being paid.

FDHO 1426 I am a casual employee and my wages are based on whether I am there or not. During the time I had to show what I was earning to the child care services unit there was a statutory holiday included which made my net income increase. So I got a letter saying that my parental contribution has risen from \$115 to \$225/month. Wrote a letter explaining this and haven't heard anything. It has been 2 weeks.

FDHO 1248 I am out of work and I was told to look for work only when my son is in school. During spring break though, I was caring for him and I was told I would receive subsidy for half a month, but then I was told I would not get it.

FDHO 1019 I had a hard time getting the child care subsidy and knowing the amount that I will get.

FDHO 1302 Not all the staff treat you the same. Some staff are nice but others are rude. They don't try to take the time to understand me or to explain things so I can understand them. When I complained about having to pay two different day cares at the same time I was told that that's just the way it is. I don't think that is right.

FDHO 1089 The day home I was using before had to close and we ended up having to move 4 times. So we had to do paperwork 4 different times and no one knew what the other worker from the child care unit was doing. They were not organized.

FDHO 1186 The forms get passed from desk to desk and there is no one to deal with immediate forms. They can cut you off and it takes a long time to get approved. They are supposed to help us, but really they are not.

FDHO 1329 The unit is not consistent. We were not contacted right away about information that was needed on our application.

FDHO 1384 There was a miscommunication problem. I would have to re-send in paperwork that was already done by the day home. And the day home owner was not receiving her cheques on time because the child care unit was not organized.

FDHO 1222 They did not calculate my income proper and now I am stressed because of their mistake. They should do their job proper. How many mistakes are they going to make?

 ${
m FDHO}$ 1240 They did the calculations wrong and I had to go back to the office 4 to 5 times.

FDHO 1050 When one of the staff from the unit rang up one day my friend's husband, who was over at my place, answered the phone. I was then accused of living with a male.

FDHO 1131 When you call the service there are different workers that ask you the same questions over and over again. There are no consistency and it is very complex.

First Nation Day Care Centre Clients

FNDC 1052 Because I am not the legal guardian of the child that sets up a problem and I get no help from Social Services. I am a grandmother that is about to retire and there is nothing put aside for me.

FNDC 1223 Child care subsidy lost my forms. The first time they approved me. It took three times for me to get approved. I know several people who said the exact same situation. This is becoming a repeat of what I went through. They did not approve me three times because they said I did not fill in my applications. I dropped the forms off and they lost the forms, but did not admit to it. Something should be done.

FNDC 1177 I sent an application in to the unit without some information and they didn't contact me about this. They should be more informative.

FNDC $1042\ I$ was told that I never filled in a form (which I had) and as a result my subsidy was cancelled. I had to go to the Minister to get it sorted out. It was then resolved.

FNDC 1382 There was some confusion between my subsidy and my "ex's" subsidy. He had a subsidy and I also had a subsidy. They had it confused for three months.

FNDC 1462 They lost my subsidy forms before. They always need to see my pay stubs even if there are no changes.

For Profit Day Care Clients

FPDC 1220 I had a job, but I had to quit because I could not afford to pay for care. They say they are there to help parents and yet they deny applications or cut you off. When I was down and out I had no choice to quit because no one else could take care of my child.

FPDC 1390 I had joint custody with my daughter's father and he would not go down and sign the papers for subsidy without being hassled. So I had been told that my daughter could only attend half of the time at day care. It took 5 months to convince them that I was the main parent in my daughter's life, and her father had nothing to do with her, before they would give me full subsidy.

FPDC 1086 I had put my application in late for subsidy and was denied funding. I had to come up with extra money to pay for it.

FPDC 1437 I initially had my application for subsidy approved, then I got promoted, and therefore earned more money so I reapplied. I was then declined. I had a colleague though, that was earning more than me who was approved so I had to reapply and was approved.

FPDC 1321 It was a complicated issue to separate me and my spouse's subsidy files. They made it very hard to separate our files during a divorce.

FPDC 1015 Late notifications and no pre-warnings before suspending benefits.

FPDC 1001 Not following up on a child pornography investigation on a child care worker in a day home; in particular the day home owner's response to the situation. In the same day home the owner had "boyfriends" moving in regularly and there was drugs brought into the home too. These people should have been

screened as if they were residents of the home. There should definitely be better regulations on these day homes.

FPDC 1200 Several years ago I was accused by an unknown person. They froze my child care during a long weekend that I had to work. They should have called me first and not freaked me out. I had to talk to a lady for an hour and told her this is my situation. They should have been professional and phoned me first, instead they believed someone else.

FPDC 1130 They're not giving me any subsidy right now. My common-law is presently looking for a job. There are others out there looking for a job and are receiving subsidy.

FPDC 1291 We had applied for subsidy and were denied. I was a little confused as to why and it was later explained to me. The woman who explained it though could have been more courteous about it.

FPDC 1393 When my child went to kindergarten full time his after school care went down to a half-time position. The child care services unit told me that my subsidy would go from \$450 to \$225 because my son is in day care for less than 100 hours. I was concerned that this would mean he would lose his position at the day care centre. I had to write to my MLA about this. There are a lot of people in a similar position.

FPDC 1056 When sending in the applications for the subsidy, I often have to take in more forms as they are often lost or misplaced.

Non Profit Day Care Clients

NPDC 1150 A consistency with subsidy payments.

NPDC 1262 Application process was very slow.

NPDC 1245 At times I have not received all the necessary information. There also hasn't been adequate follow-up.

NPDC 1359 Every time I re-apply my subsidy always changes.

NPDC 1226 I experienced preconceived notions by a staff; they made me feel 2 inches small.

NPDC 1002 I had a few problems mainly when it was in the old building, particularly with the speed of processing of paperwork and keeping track of it.

NPDC 1396 I have had lots of problems with them. Somebody should be bilingual at Child Care Services. Now I don't know if this is the fault of the Unit or the fault of the day care, but every two months I have to phone Child Care Services Unit because the day care is not being paid. I have to always phone on the day care's behalf because of a language barrier. The workers at the day care can't figure out the system or what they are supposed to do. Finances are hard to discuss in your first language, let alone your second language. I have to continually get involved which I shouldn't have to do. We do have a full-time French day care, so somebody should speak French at the Unit. At least they should bring in someone part-time who speaks French.

NPDC 1171 It was hard to initially get the ball rolling on filling out the paperwork. I had to wait.

NPDC 1356 My wage increased by \$100.00 and child care subsidy decreased by \$100.00

NPDC 1299 Paperwork being lost. Subsidies not coming in when approved, and having to re-approve it when it has already been approved. Very limited enforcement of policies in day cares. Too much paperwork and not enough field work.

NPDC 1446 They had two files on me and therefore were asking me for double documents before they worked out what was going on. This gave me a lot of run around.

NPDC 1443 When I go there, there isn't always someone there to answer my questions.

NPDC 1229 When I spoke to someone there she just said, "Well, that's just the way it is." It is like she did not care about my situation.

NPDC 1204 When determining subsidy the unit only looks at 'part-time' or 'full-time' and nothing in between. It would be better if they had a 'three-quarter' time category for those earning just over part time wages.

Q16.1 Final Comments

Family Day Home Clients

FDHO 1308 Child care providers are not compensated enough.

FDHO 1426 Child maintenance is not included as a taxable income but is included when it comes to calculating subsidy. It don't think this is right.

FDHO 1131 I am very unhappy with the system. The service in Alberta is more user friendly than the Yukon system.

FDHO 1302 I think that it should be easier to find out who to talk to if you have a complaint with the way day cares can currently charge you. There should be someone to tell these complaints to.

FDHO 1183 I wish there is more child care services that provide overnight care, special needs and clean home.

FDHO 1164 I work full time and I have to pay lots for day care. I have other bills to pay as well and I think the cost for child care should be lowered.

FDHO 1333 Increase the subsidy for single parents

FDHO 1119 Increased pay to child care workers would increase better care giving to our children.

FDHO 1436 It is not my choice to have my son in day care. I pay for my day care on the basis of a court order.

FDHO 1318 More training for care providers and a list of child care vacancies available.

FDHO 1252 No, we have covered it.

FDHO 1089 Open up more day homes so that they are not overcrowded and you don't have to wait to put your child in a day home.

FDHO 1113 Provide more funding for more day cares to open.

FDHO 1280 Q.7 The government should cover extra cost for better quality care for smaller children.

Q.8 I want it noted that in the past 12 months I have gone to three different child care places.

FDHO 1036 The Child Care Services Unit needs to have clearer and more simple communications with people and explain it to them better, particularly how much is actually subsidized and what the parents' contribution actually is. At present it is very unclear.

FDHO 1125 This survey is kind of long. It should be a short survey.

First Nation Day Care Centre Clients

FNDC 1435 Hope that all the services remain and even improve at the Child Care Services Unit.

FNDC 1042 I fully support day cares and the Government subsidizing low income families to access day care.

FNDC 1096 I think it is good to do surveys like this.

FNDC 1301 I think the day care should be open during the summer months.

FNDC 1034 More people should know about the system when they are starting out.

FNDC 1259 No, I am pretty happy with everything

FNDC 1052 It is important to increase the wages of child care providers because if they are not adequately paid they don't have much dedication to their job.

FNDC 1117 Raise funding for child care worker wages.

FNDC 1028 There should be a new playground built at the Trinke Zho Day Care.

For Profit Day Care Clients

FPDC 1325 Day cares should have to hand out permission slips before a child leaves the day care facility. I also feel accidents go unreported. I am finding out from my child that she was hit by another child. This should be told to me.

FPDC 1001 Day home regulations need to be looked at.

FPDC 1182 Everything is wonderful that they do. It is great for me to have this subsidy along with receiving welfare. I feel pretty lucky. I don't think we could get this in any other province.

FPDC 1386 I think that the day cares should be more understanding and flexible with their hours. Some parents hours are different than others and they don't understand that.

FPDC 1082 I think that they should increase funding for low income families. Day cares can be expensive.

FPDC 1296 I wanted to reiterate that child care workers are paid too little.

FPDC 1015 I wish I didn't have to work as much. It would be nice if there was a designated day each month where parents can spend a day at day care with their children and get paid for it! We are both the legal guardians - there is a 50-50 split.

FPDC 1357 I would like to see the child care providers have increased wages. I would like to see YTG be stronger financial advocates.

FPDC 1278 Make it easier for single parents.

FPDC 1029 More of the day cares should be judged against the standards of the Tree House Day Care because they have an excellent program and excellent staff.

FPDC 1331 My daughter told me that a child care worker was smoking in the forest while being with children, and the smoker said "run ahead". I feel that I am unheard with my concerns and I strongly agree with the screening of caregivers.

FPDC 1024 No, everything is fine.

FPDC 1065 Please pay more to workers without increasing cost to the user, which is hard to do.

FPDC 1053 Surveys like this are a good idea.

FPDC 1124 Thank you for paying attention to child care. Child care programs could be more individualized and more child directed. There is not enough money put into day care.

FPDC 1233 The child care workers need to be paid more. They are really, really worth it. And we do need more after school programs.

FPDC 1135 The reference checks and security clearance for child care workers should be improved. There should be a database that the public can view regarding complaints against child care workers. The hours available for child care should be extended. It seems to be restricted to day services only which is not always suitable. The government needs to step in here.

FPDC 1228 The wage increases should be targeted to higher qualified child care workers.

FPDC 1085 They did a good job.

FPDC 1174 They should offer funding for after school babysitters.

FPDC 1056 They should make it easier for split families where both parents have custody. Particularly where one parent is eligible for the subsidy and the other is not. There should be a fair split of the subsidy between the two.

FPDC 1035 It is very important to assist in the recruitment, training and retention of child care workers because properly trained staff stick around longer which is very important for the children.

Non Profit Day Care Clients

NPDC 1105 Bring in French workers from out of town, and pay them well. You get a higher pay in Quebec.

NPDC 1231 I am happy with everything.

NPDC 1188 I do this all through the mail so I don't have a lot of dealings with the Child Care Services office.

NPDC 1226 I feel like I am reminded every month like a child to give my pay stubs. It should be requested every 6 months. I did hear that a single parent male was not eligible for child care subsidy. (I think this is terrible if it is true.)

NPDC 1103 I hope that something good happens from this survey.

NPDC 1316 I informed the day care at the college that my child was going to be returning in the fall. They said they tried to call me to verify her return and at this time we were out of town, so they gave the spot to another child. I had to put her in this present day care and I'm satisfied with this day care.

NPDC 1262 I think that it is great how you guys are doing a survey.

NPDC 1221 I think the day care should be subsidized and a nanny is cheaper than daycare rates.

NPDC 1059 I was very pleased with the service received from the Yukon Government Child Care Services Unit. I was under unusual circumstances and the staff

member went out of her way to process the application the same day. I was very pleased by this.

NPDC 1027 I would like to see better funding, more programs for the children and better research into the backgrounds of people responsible for caring for children.

NPDC 1356 I would like to see older children in after school programs instead of having them in day care. My children are too old for child care and there is nothing for their age group. I had to quit my job for 1 year because they did not have child care on weekends.

NPDC 1150 If I wasn't subsidized by Child Care Services I couldn't afford it.

NPDC 1346 It is a valuable service for people that need it. Any funding provided should be either maintained or increased.

NPDC 1181 It is an important service for low income families.

NPDC 1171 More programs for children should be implemented, such as gymnastics and exercise to build them up and get them prepared for school

NPDC 1139 My children are no longer in day care. I took them out in December.

NPDC 1055 Taking care of single low income earners, providing good child care programs and caring for special needs children are all important.

NPDC 1179 Re-look at the prices. I disagree with the price range.

NPDC 1446 The high cost of day care would be justified if the workers were paid more.

NPDC 1127 The run around I have to do because of being on Social Assistance is very difficult. I'm sometimes very depressed and it's hard. They need to provide care for an evening out for parents. I could attend a class on how to deal with stress.

NPDC 1408 The subsidy doesn't take into consideration other bills. They should consider vehicle, mortgage and other bills.

NPDC 1018 They need to look at the subsidy particularly the inclusion of child support payments (which are not taxable) but through which I get penalized. I therefore have more out of pocket expenses through paying a higher parent contribution so it is hard to make ends meet.

As for Q.10, I am unable to choose any actions as being more or less important than another. They all are important. Not one action deserves less attention than another. Each benefits or provides something that is presently not available now.

NPDC 1002 We need more day cares and more options. We need more care workers who are mature and make us parents feel comfortable by enforcing discipline.

NPDC 1202 Funding for children with special needs should be increased. I know someone with a special needs child and they need to pay a lot more.
